Guidelines: Requesting NEFDA Resources

I.

Purpose

The intent of these Standard Operating Guidelines is to provide Dispatch Centers with the information to request Northeast Fire Department Association Specialty Teams and Resources.

II.

Teams and Resources

- A. Specialty teams - Bomb, Hazardous Materials, Swift Water, and Technical Rescue.
- B. Special Resources consist of the Air & Light Vehicle and the Mass Casualty Vehicle.

III.

Needed Information to Provide to the Specialty Teams and/or Resources

Provide the following details to the Dispatch Center listed below:

- A. Nature of the incident.
- B. Address of the incident.
- C. Radio channel the incident is operating.
- D. Telephone number of a contact on scene.
- E. Any other pertinent information such as a rescue or body recovery; or if victim is floating away or stationary.
- F. Emergency or Non-Emergency response.

IV. Requesting the Team or Resource

Bomb Team (EOD 22) - Contact NRHW at 817-281-1000. The Bomb team will contact the requesting agency via telephone or radio. NERT (Northeast Emergency Response Team).

Hazardous Materials- Contact NRHW at 817-281-1000.

There are two types of responses for the Hazardous Materials Team; the requesting agencies' Incident Commander should make the Level 1 or Level 2 request.

- In a Level 1 response, North Richland Hills HM22 with 3 hazmat technicians, Roanoke HM66 with 2 hazmat technicians, and the North Richland Hills Battalion Chief will respond to the requesting agency.
- In a level 2 response, NRHW Alarm will call the following agencies Alarm office to respond their on-duty hazardous materials technicians in addition to the response outlined in a Level 1 response: Bedford, Eules, North Richland Hills, Richland Hills, Roanoke, Southlake, Trophy Club, Watauga, and Westlake.
- The Hazmat team will respond on **NRHW Fire 7**

Swift Water Team - Contact NRHW at 817-281-1000

- The Swift Water Teams will respond on **NRHW Fire 7**

Technical Rescue Team - Contact NRHW at 817-281-1000

There are two types of responses for the Technical Rescue Team; a full team response or a single Heavy Rescue response.

- A full team response is;
 - 2 Heavy Rescues with 6 Techs
 - 9 Techs from Southlake, Keller, and Hurst
 - 2 Chief Officers from HCFR and GFD
 - 2 Hazardous Materials Techs from Eules
 - 2 Medical Specialists from Watauga
- A single Heavy Rescue response is;
 - Heavy Rescue with 3 Techs
 - Battalion Chief from the Rescue's city
- See NEFDA Rescue SOG for assignments
- The TRT team will respond on **NRHW Fire 7**

The NEFDA BC should also be contacted by NEFDA Agencies if they send NEFDA resources out of NEFDA so the NEFDA BC knows what is available at all times.
