- 6. Should any question arise that is not covered in the USEF Rule book the same shall be referenced to the Show Committee whose decision shall be final.
- 7. Failure to enter the ring within three minutes of being called will incur elimination.
- 8. All fees must be paid and entry complete before numbers can be issued.
- The Committee reserves the right to cancel, combine, change location or add any class(es) or schooling deemed necessary.
- 10. Ties for first place will be jumped off, all others will remain tied receiving equal points, ribbons and prize money.
- 11. All riders must wear proper attire including proper headgear at all times mounted on the showgrounds.
- 12. Horses must at least one other class in the division to be eligible for prize money.
- Prize money and Championships will be awarded at the conclusion of the division at the show office.
   Please allow one-half hour for processing.
- 14. All pets must be leashed.
- 15. Jump orders will be constructed at the discretion of the show management by the steward.
- 16. A processing fee of \$100.00 will be made for all non-negotiable checks. Any returned checks not "made good" within 10 days will be forwarded to the USEF for collection per USEF Rule XV, Art. 1508.
- Life, senior active and junior active members shall be eligible to participate in all classes at Regular 17. Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races: 4) classes for 4-H members: 5) walk trot (exception: Friesian performance FR222) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes. Should the veterinarian on call be needed to complete permanent measurement of horses or ponies, then the appointed time for said measurements will be 10:00 a.m.
- 18. ALL ARRANGEMENTS FOR MEASUREMENTS MUST BE MADE IN ADVANCE THROUGH SHOW MANAGEMENT BY THE WEDNESDAY BEFORE THE COMPETITION. Phone (908) -534-8833 for information and procedures. Day measurements will of course be available at any time throughout the show day.
- Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. Theparent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.
- 20. Sharps containers will be located in the show office.
