78th FRA and 76th FRA Auxiliary 2022 East Coast Regional Convention (ECRC)

This year's ECRC was held in Williamsburg, VA at Fort Magruder Hotel and Conference Center and hosted by Branch/Unit 40 and Branch 293. Our Branch delegates Shipmates President PRPEC Randy Phillipp, PNC Paul Gunther, and Thomas Rauch were all in attendance

The ECRC started with the Opening Ceremonies on Wednesday, June 29, 2022 at 1300 with Fleet Master Chief John Perryman as the Keynote Speaker. Later that night there was a Welcome Aboard Party held with a Country Western theme.

On Thursday, June 30, 2022 at 0900 the FRA Business Session was called to order. Reports of the Regional Officers, President Chris Murray, Vice President Gabriel Falu, Secretary Paula Falu, Treasurer Phillip Stone and Jr. PRPEC Randy Phillipp were read. The State and National Legislative Representatives from MD, VA and National Headquarters reported on Veteran programs and laws that pertained to their state or the Nation as a whole. There were no reports for DE, DC and NC.

lext on the agenda was the Reports of the Standing Committees. This is where the results of the Regional Branches' submissions for the various committees were revealed. Our Branch placed 1st in Group IV for Americanism/Patriotism, Youth Activities, Public Relations and Veteran Services. Also placed 2nd in Hospitals, Welfare, & Rehabilitation. The Budget & Finance and Audit Committees conducted their reports as well. Next was the Bylaws & Rules committee, which reported that all ten resolutions that were submitted were Out-of-Order because the submitted date was the same as the voted on date on the Resolution. Resolutions are to be reviewed at two regular Branch meetings before they are voted on. There was a motion to add a Standing Rule 4 to the ECR Standing Rules, for the outgoing Branch Secretary to send a copy of the Branch Bylaws to the Regional President on an annual basis, it was seconded and approved by all after discussion.

The Time & Place committee reported that there was no Branch submissions to host the 2023 and 2024 ECRC and Mid-Year Meeting (MYM). After discussion, the following was agreed upon for hosting these events: 2023 MYM, Branch 99 (Tentatively); 2023 ECRC, Special Committee, Shipmate PNC Valerie Toulotte Chair; 2024 MYM, Branch 293 (Tentatively); 2024 ECRC, Branch 24.

Under New Business the 2022-2023 Elections of Regional Officers were held. The following officers were elected:

Shipmate PRPEC Paul Phelps installed Shipmate Robert Oliveira as RVPEC. Good of the order was then held and the business meeting was adjourned by RPEC Murray.

That night a banquet was held and Shipmate Gabriel Falu was installed in a mock installation. Shipmate Gabriel Falu will be officially installed at the National Convention in October. The night continued with dinner, live entertainment and dancing. Overall another great Convention!!! (The meeting minutes will be distributed once received.)
