DPW Report: DPW Supervisor, John Ihrke reported to Council that no public hearing had to be held for the Sewer Lagoon so as of April 1st, 2009 we are working under the new permit. Cell #2 is still not ready for discharge do to weather conditions. Some issues still exist with communication from the Water Treatment Plant and the DPW Garage Panel with Air Advantages equipment. A PLC in the panel in the garage could solve the problem. When DJE begins the preliminary telemetry system for the Sewer Lift station a PLC has to be added to the panel. The PLC will be able to be utilized for the Water Treatment Plant as well. Supervisor Ihrke would like to table, until the next budget year, having Jeff Hansen from Workhorse Engineering work at developing "Design Standards" for the Village regarding type of equipment use and specs for any additional developments. John Ihrke presented bids for the Water Tower Inspection.
