Supervisor Frazier called the meeting to Order to Order and Salute to the Flag at 7:30PM

Supervisor Frazier noted he neglected to add the Animal Control Report to the agenda and would like to do so as items no. 12 which was seconded by Councilman Welsh and all were unanimously in favor.

Councilman Welsh made a motion to table the approval of the March 6<sup>th</sup> 2024 minutes until next month which was seconded by Councilman McGivney and all were unanimously in favor.

## **Supervisors Report**

- Roadside clean-up is approaching in conjunction with the UVFD. All meet at the Clove Firehouse, bags and road assignments will be provided to all who attend.

#### **Board Member Reports**

Councilman Welsh – walked around the Park and reviewed all the roofs that were at risk. He did this from the ground. He noted 8 Tymor park is in desperate need of replacement but was unsure if the other roofs needed immediate attention. He hopes the others can be repaired and spread out the cost over time.

Councilman Cartalemi- noted the Town received a letter from the Dutchess Gaelic Athletic Association (GAA) thanking the Town for investigating if a field could be put at Tymor but have made plans with Town of Beekman as they are growing rapidly and needed a field venue. He spoke with Kieran Mitchell, President, and they are still interested in having the Gaelic Festival at the Town but needs a rental agreement. He asks how this can impact the budget without having revenue of the field rental and would like to discuss at a later time.

Councilman Durland – in light of last meeting, he spoke with residents regarding the library issue. He has also been assisting Building Inspector, George Kolb on an issue on Cole Road. He also surveyed some of the roofs and would like to come up with a game plan. He agrees 8 Tymor Park Roof needs to be replaced as soon as possible.

*Councilman McGivney*- reminded the residents of the March 30 'Egg Hunts for All'. Also wanted to wish Town Hall Employee Laura Sumner a Happy Birthday.

Supervisor Frazier added that he and Engineer Tom Harvey reviewed the roofs in person and that Mr. Harvey agreed they are all beyond their life expectancy. The Park Manager will have a visual report later in the meeting. Supervisor Frazier explained they really cannot be repaired any longer as the existing shingles are too brittle to attach newer material too. Councilman Cartalemi noted that the engineering report will contain priority levels and understood from Mr. Harvey that some could be patched. Due to the conflicting assessment the Town Board will wait for the report before they move forward.

**Town Clerk Report** Clerk Casey reminded residents about Shredding Day on June 5<sup>th</sup>. She also thanked Demar Osika for the Relay for Life luminary bag event. She also noted that April 1<sup>st</sup> is opening day for NYS fishing and to obtain a fishing license for NYS and Tymor Park at the Town Clerk's office, Tymor passes are free to residents.

## **Tax Collector Report**

Tax Collector Saglibene reported that as of the 29<sup>th</sup> of February the collection percentage was 81%. As of today, she is at 87% with 156 bills remaining. The DC check for 1.3 million was delivered to Dutchess County on Friday. Ms. Saglibene reminded the residents that there is a 2% penalty after March 31<sup>st</sup> and urged the residents to get their envelopes "hand stamped" to ensure a proper postage date. There were 2 visitors in the month of March on Saturdays with 2 remaining Saturday's to go.

### **Highway Report**

Superintendent Kading said crews have been doing road repairs such a potholes, clearing ditches and tree removal. All the winter equipment has been cleaned and put away. The 2024 Highway-284 paving document has been presented to the Board. Unfortunately, there isn't enough funding to do oil and chip on the 2023 roads that were paved. They will prioritize based on road condition. The Highway Dept. is in possession of the new excavator and thanks the board for their approval. The DEC burn ban is in effect until May 15 and Mr. Kading asks the brush being brought to the Highway garage on restriction so they pile does not get out of hand. The roof at the highway garage is leaking.

## Recreation, submitted by Recreation Director Maggie Collins

This past weekend we hosted volunteer hours for students and adults to help stuff thousands of eggs for our Egg Hunts for All event. Thank you to everyone who came out to help with the preparation for this event. Spots for our Egg Hunts for All are filling up quickly. Registration is required for this free event and details on the four different accessible hunts can be found on the Parks and Rec website. Next week we will be running our Full Day TGTT Spring Break program for the local school district's time off. This will run weekdays from March 25th-April 1st from 8am-6pm. We will enjoy themed crafts and activities, the great outdoors and fun with friends. Seating is limited and registration can be found on the Parks and Rec website. While all of our other Summer programs are full, we do have very few seats open for our TLC program. More information on this program and registration can be found on our Parks and Recreation website.

Ms. Collins also submitted a report to the board in light of minimum wage increasing and the impact to the budget and how she feels it should be corrected. The Board will review and get back to her next meeting.

# Parks Report January 2024 Submitted by Vincent Germano

- We have been working on getting the pool filter tank project finished. We have managed to move the tank into the building and transport the filter media over as well. Once we position the tank we will replumb it and put in the filter media and rebuild the wall we had to take down to get the tank into place.
- We have been continuing trail work, including taking care of a number of trees that fell during the recent storms, we also built a temporary foot bridge to cross some flooded trails at the bottom of the gorge. We have also cleared behind the tennis courts and more of the Creekside along Tymor park road.
- We have been getting the rental house at 11 Tymor Park Road ready for future tenants, this has mainly consisted of removing some things we stored in the garage and cleaning the house.
- The project at Godfrey Park is progressing, the installers have attached the cupola that was on order and are going to come back to adjust the slide to stop water from pooling at the bottom. Once the weather warms up more we will be doing a lot of landscaping to clean up from the building process.

A comprehensive PowerPoint presentation of all the roof leaks was compiled by Mr. Germano complete with internal and external pictures was provided to the Town Board.

## **Equestrian Center**

Loretta Ryan, Equestrian Center Director, she invited everyone to visit the Equestrian Center a noted, it is the only NYS park with an equestrian center. Tymor Park is the only New York State park to have an equestrian center. The Equestrian Center, has been hosting over 30 years of

activities that have continued to make Tymor Equestrian Center a wonderful place to ride, have events like our annual draft horse pull and our horse show series. We also host organizations that rent the facility for their own equestrian events. Last year we had our composting toilet installed, so now we have a new wheelchair accessible bathroom along the wood line near the ring. I'd like to quickly highlight the annual draft horse pull. This has been a long-standing tradition here at our town, thanks to Betty and Rich Albrecht. Last year we held our 28th pull and what a turnout we had. We had the biggest competitive field of horses since hosting the horse pull {9 teams in the lightweight and 10 teams in the heavyweight). This year's Draft horse pull will be on Saturday June 1st, starting at 11am and runs throughout the afternoon. If you have never been to this event, I strongly encourage you to bring the family to see some real horse power. This event is only possible through the generosity of the horse pull sponsors, which funds the prize money for the competitors. If anyone is interested in becoming a sponsor, I have sponsorship forms available for 2024. We have the following dates for our English/western horse show series, that start at 8am and run though the late afternoon: Sunday, April 28th, Sunday, June 23rd, Sunday, September 29th We have added a new division at the horse shows, Tymor All Stars. These classes are tailored for riders of all ages enrolled in an equine assisted services or therapeutic program. All of these free family events are posted on the Tymor equestrian Facebook page and on our town website. I also want to thank all of the volunteers that have helped out and supported our 2023 events so please know how appreciative I am for all the support. We can always use a helping hand...so if anyone has an interest in helping out, no experience required, please let me know. We would also love to have a ring painting party in the spring so please stay tuned for a future date, and let me know if you would like to participate. I look forward to seeing everyone at the equestrian center event s. I would like to close by expressing my appreciation to the park & town employees and the town board members for their continued support of the equestrian center.

#### Library

Updates from the Library submitted by Library Trustee President, Amy Watkins: The library welcomed back Diane Capizutto at our last meeting. In her role as trustee she will be providing updates on fundraising in conjunction with the Library Fund.

Unfortunately, Art Mattiello resigned as a trustee. He is taking time to focus on his family. We appreciate all of the time and dedication he has given to the library and wish him well.

Several of the Trustees and the Library Director are scheduled to meet with Maggie and the Rec Department next week to discuss the Summer Camp and needs for the shared space.

The library volunteers have been meeting every Saturday, typically between 12-3. We have prepared the first round of donated books for bar coding to enter them into our system.

We received a sizable donation from the Estate of Jeanette and Paul Wagner. We are entirely grateful for this generous gift to our library. These will be the next books our volunteers will be unpacking, sanitizing and preparing for barcoding.

We applied and were approved to offer Talking Book and Braille Library services. This information will be added to our website, but additional information can be provided by reaching out to our director.

The Union Vale library will be participating in the Neighborhood Forest tree planting program. Families have registered to receive free trees. The director has been in contact with these families about the pick-up time.

Update on Overdrive/Libby. Thank you to the Town Clerk! Andrea was exceptionally helpful in trying to locate two checks that were sent to vendors and not received. Thankfully, stop payment was placed on these checks and new checks have been issued. Unfortunately, this has delayed Libby being set up since payment was not received. We will email the residents once it is available.

Lastly, the trustees are excited to welcome Karen Foley as our PT Director. We have processed her application and are waiting for the paperwork from the Supervisor to be finalized. The sooner this can be completed, the better for our residents. Karen is a long-time resident of Union Vale

whose children also worked at the Rec Summer Camp. She will be a wonderful addition to our team.

## Animal Control Report January 2024 submitted by ACO, Mary Jean Calvi

During the month of January, there were no lost dogs. One dog, found by a Good Samaritan on Rt 82 in Verbank was brought to HVARS in Poughkeepsie. After much collaboration, this dog was reunited with its owner. Please note that HVARS is not the contracted shelter for the Town of Union Vale. Any found dogs in the Town of Union Vale are sheltered at Mutts Mansion, Rt 376 in Wappingers Falls.

Received notification from Dr. Demba Keith (MD), the Rabies Coordinator with the Dutchess County Department of Behavioral & Community Health that there is going to be a Rabies Informational Session for all DC Animal Control Officers. The past few months have seen a number of rabies positive animals so everyone should be cautious in their dealings with wildlife or unknown domestic animals.

## **New Business Vacant Properties**

Supervisor Frazier noted this was a parcel donated a few years back, the fire dept has expressed interest in both pieces, the former Redel property across from UVFD Station 1 and a parcel on top of Wingdale Mountain. In his experienced he feels as these are liability as expenses to maintain. The DC Soil and Water and DPW feel they can use the property on Route 82 as a drainage area to correct storm flooding often affecting that area. This is for the Board to think about and discuss at a later time.

Councilman Durland mentioned there was an existing conversation about correcting that intersection to square it up to Route 82 which the County proposed 3 different options. Councilman Cartalemi also noted the CAC had an idea to utilize the land for a community garden. The all agreed both options could be continued even with the land being deeded to the Fire Company.

# TOWN OF UNION VALE TOWN BOARD RESOLUTION NO.20-2024: AUTHORIZING SUPERVISOR TO EXECUTE AND FILE ALL DOCUMENTS AND TAKE ALL ACTIONS REASONABLY NECESSARY TO COMPLETE THE PROCESS FOR THE CELL TOWER AT 43 DeFOREST LANE

The following Resolution was offered by Councilman Welsh and seconded by Councilman Cartalemi:

WHEREAS, on April 18, 2019, the Town Board of the Town of Union Vale adopted Resolutions numbered 19-23, 19-24 and 19-25 related to approving an Option and Ground Lease with related SEQRA matters regarding an application by Homeland Towers, LLC for the installation and maintenance of a telecommunications tower and related equipment on property with a street address of 43 DeForest Lane and identified as tax map parcel 132200-6659-00-960870-0000; and

WHEREAS, on June 6, 2019 the Town Board of the Town of Union Vale adopted Resolutions numbered 19-27, 19-28 and 19-29 approving an application by Homeland Towers, LLC for the installation and maintenance of said telecommunications tower and related equipment on said property; and

WHEREAS, by NOTICE OF PETITION dated August 16, 2019, the Town of Beekman commenced an Article 78 proceeding against the Town Board of the Town of Union Vale seeking to nullify and invalidate all Resolutions and approvals granted by the Town of Union Vale related to the installation and maintenance of the said telecommunications tower and related equipment, with such proceeding being identified by Index No. 2019-53354; and

WHEREAS, by DECISION AND ORDER dated May 11, 2020 and entered on May 12, 2020, the Supreme Court of the State of New York, County of Dutchess, ordered, adjudged and declared that all such Resolutions were valid and of full legal effect, not made in violation of lawful procedure or affected by errors of law, and not arbitrary or capricious and thus dismissed the action or proceeding in all respects; and

WHEREAS, by NOTICE OF APPEAL dated June 9, 2020, the TOWN OF BEEKMAN appealed the said Decision and Order to the Appellate Division of the Supreme Court of the State of New York, Second Judicial Department; and

WHEREAS, by DECISION & ORDER dated September 20, 2023 and entered on September 23, 2023, the Appellate Division of the Supreme Court of the State of New York,

Show a full Department, a further fudgment of the Supreme Court, Dutchess County, dated May 11, 2020, holding that the petition was properly denied and dismissed, and declaring that the Resolutions were valid; and

**WHEREAS**, the deadline for the Town of Beekman to file a further appeal in this matter has passed without any further appeal having been filed; and

WHEREAS, the Town Board of the Town of Union Vale thus intends to proceed with approvals previously granted and complete the parkland alienation process, and further intends to authorize the Supervisor to execute and file any and all documents and take all actions reasonably necessary to effectuate such approvals and complete the parkland alienation process; and

WHEREAS, the Town Board hereby ratifies its prior SEQRA determinations and classifies this current matter as a Type II action for purposes of SEQRA pursuant to 22 NYCRR 617.5 as continuing agency administration and management, not including new programs or major reordering of priorities that may affect the environment;

**NOW, THEREFORE, BE IT RESOLVED,** that the Town Board of the Town of Union Vale, hereby authorizes the Supervisor to execute and file any and all documents and take all actions reasonably necessary to effectuate such approvals and complete the parkland alienation process.
