At our 2022 Synod Assembly, we gathered under the theme *Imagine: Endless Possibilities in God's Grace*. As we live into the future God has for us, we see what we had once only imagined start to take shape in concrete ways.

This year has brought a new way of meeting the needs of congregations in transition as we have explored various models for pastoral ministry. Most prominent among them is what we call a Bridge to Settled model. This new model allows congregations to work with a Bridge pastor (different than an intentionally trained interim) while forming a call committee and engaging in the call process with the understanding that both the pastor and congregation are open to transitioning from the Bridge into a settled call. It is not the right model for every congregation, but it has greatly benefited many.

We have also seen a gentle uptick in individual congregations exploring partnerships of all kinds. Some congregations are forming new joint parishes, others are working together to meld two parttime calls into full-time work for a single candidate, and still others are merging weekly confirmation classes. More and more of our congregations are realizing the profound benefits and joy of collaboration.

It has been fun to walk alongside folks as they lead their congregations into new ways of being the People of God in their community in this time and place.

As 2023 approaches, I remain ever hopeful for all that the Spirit will continue to do in and through us as the Southeastern Minnesota Synod. Looking ahead to our next Synod Assembly, I am excited to announce that we will be joined by Drs. Susan Brower and Matt Bloom. Drs. Brower and Bloom will give us tools to understand our communities as they are presently and as they are projected to be. They will also explore ways congregations can ignite flourishing in the communities to which they are called.

I am excited to continue imagining alongside each of you as we discern what God is doing in our midst and calling us to do. What a wonderful time to be the church together for the sake of the world.

Pastor's Report

Dear Brothers and Sisters in Christ,

The beginning of 2022 brought about additional changes for the faith community of Redeemer. At the January Annual Meeting the congregation voted to share in a ministry partnership with Concordia Lutheran Church of Pickerel Lake which included sharing me as your pastor. As we began the ministry partnership on March 1st both congregations agreed to alternate the Wednesday Lenten services which included a meal. It was a very successful partnership beginning. I give thanks for your openness to experiment with this new ministry partnership. Change can be a challenging process and you have moved through the experience with willingness and grace.

Redeemer Lutheran's Church Council has led the congregation faithfully throughout this year, tending to the needs of the congregation. They have gathered each month to care for the matters related to our ministry, our mission, our worship needs, our financial needs, and our building needs. Thank you to all the Council members, our church staff, and committee members for their service to God's ministry here in this place. Well done faithful servants!

In May our congregation again decided to participate in alternating worship services with Concordia for the summer months. Our worship services were held at 9 am and we hosted a fellowship time following worship. Thanks to the many folks who volunteered to serve we had a successful summer of worship and fellowship which included an outdoor service during Morin Lake Days in Alden.

I had the joy of celebrating with the young people of the congregation during their Vacation Bible School time. What a fun few days we had! There were so many dedicated volunteers sharing in leading a faithful and joyful VBS. Thank you to our devoted education leaders here at Redeemer. During August the congregation voted to continue their ministry partnership experiment with Concordia Lutheran for another 6 months. August was also a month of medical leave for me as I experienced knee-replacement surgery. My sincere appreciation for your support, prayers, and care during my time of recovery.

The fall brought the next partnership opportunity as the confirmation classes of Redeemer and Concordia began holding joint class time alternating between the two congregation locations. It has been a delight to share in educating these young people and building faithful relationships with them. Our two congregations also come together to offer Youth Group opportunities for our 6th through 12th grade students. As we meet each month the students have been sharing in prayer, participating in "get-to-know-you" activities, enjoying fellowship, planning for future activities, and spending time in service projects. One of our future goals is to have some students attend the 2024 ELCA Youth Gathering.

Worship time in the fall was shifted to 8:30 a.m. to give a bit more time in between the two congregation services for me to share in fellowship, connect with our Sunday School, meet with Confirmation students, and travel safely from one church to the next. I know this earlier time has been a challenge for some in our congregation and I appreciate your patience and openness as we move through these changes.

During November I offered a Bible Study for adults of the congregations. It was a pleasure to explore God's word with all those who participated. The end of November began our Advent season and the meaningful worship experience with our Hanging of the Greens Service. What a worship success! Thank you to the wonderful volunteers who planned and shared in leading the service.

In December, the Sunday School and Confirmation students provided a great Christmas program under the leadership of our Christian Education volunteers. Thank you to all those caring volunteers! Unfortunately, a winter storm prevented us from having both of our Christmas Eve services but about 100 people did gather to worship that day.

I give thanks to God for the faith community of Redeemer and my ability to share in the ministry here with you. I am blessed to be your pastor, to experience your generosity, to share in the service to others, and to experience your concern for God's people. As we move into 2023 and face the joys, challenges, changes, and opportunities that the year will bring. I am confident in God's guiding and providing for his people at Redeemer. I pray we will keep centered in God's word to guide us each step of the way, to seek God's help so that we worship him with honor and faithfulness, and to ask God's guidance so that we may serve him and his people with love and reverence.

Christian Education Report for 2022

The last year for Redeemer Sunday School has been a year filled with new programs, fellowship and engagement with our families from newborn to confirmation. We are in our sixth year using the *Spark* curriculum, (publisher Augsburg Fortress) for PreK-6th grade students. Our goal is to "spark" our PreK-6 Sunday School students with the joy, love, and peace of Jesus and His stories! Our *Spark* curriculum is age-appropriate Bible learning. The students relate with Bible characters as they navigate through the Bible, and they apply faith based actions into their own lives. We continue to provide the Frolic First Bible as our Cradle Roll gift to babies baptized at Redeemer.

At the beginning of the year, we continued to use the "Spark" lectionary curriculum in our classrooms and started sending the corresponding Spark "Family Page" in Pastor's weekly e-news. We launched our new program, "Faithful Fridays", including both after school and overnight activities for our school-age children. This program launched with overwhelming success, with more than 30 children attending each of the four Faithful Friday events.

Our summer 2022 Vacation Bible School (VBS) Theme was *HayDay*, where kids learned to "grow in friendship with Jesus". Twenty-six students attended our energy filled 3-day VBS at RLC. Each night began with "Moo-sic & More" opening skit and music. Each group of children then traveled to three stations (Hog Wild Games, Bible Adventures, and Projects-with-a-Purpose) where they learned all about friendship with God. The evening ended with a special "Friendship Finale", with music and the Bible Point for the week – Jesus will always love us. The VBS fun ended on Tuesday, with a brief celebration and taco supper where the kids shared all they had learned. The students shared their special projects, (jars of birdseed to share with feathered friends too!) the following Sunday during the worship service. A special thank you to all of our volunteers for the planning and organization to make it a great week for kids and families! We also appreciate the support from our congregation and the generous support of a Thrivent Action Team Grant. This summer (2023), we are excited to explore, *Pets Unleashed*, – <u>Where Jesus Cares "Fur" You"</u>, This year's VBS dates are June 11-13, 2023 with a special Worship by the Water celebration during the MLD worship service on June 18 – Look for more details to come!

An outdoor Rally Sunday carnival gathered our families to kick off the new Sunday school year. The event included carnival treats, inflatables and many other activities for all – young and old! Our classrooms are divided into three different agelevel classrooms, led by a classroom teacher; PreK-1, 2-4, 5-6. Our students have enjoyed combining classrooms and learning together through hands-on service activities. This year, our PreK-1 classroom made goody bags to share with the food shelf and our 2-6 grade students have been working hard to decorate our halls with new signs. The teachers make up our Christian Ed committee and are listed below.

In November, we launched our first Frolic Family event with the help of a Thrivent Action Team Grant. The first of three classes offered throughout the year to connect with our young families and little ones. We were excited to spend the evening connecting with seven of our families/current cradle roll children enjoying good conversation, pizza and family activities. Our first theme was "Thank You, God".

We ended 2022 with our Christmas Program – *Wonderful Christmas*. All the classroom leaders and additional volunteers helped out with the organization, costumes, and rehearsals. Everyone did a wonderful job! Our confirmation students assisted with the Christmas Program service and helped to distribute gift bags to all of the children. Thank you to all involved with props & costumes, the set-up, the program itself, and the tear down/clean-up of the program. Special thanks to Colleen Jahnke and Kelly Skov for help with this year's costumes and Lori Miller for coordinating Jesus' Birthday celebration.

As we close and evaluate 2022, we look forward to the coming year. We continue to navigate our changing world, utilizing creativity and the strengths of our team to meet our families where they are, by adapting to busy schedules and recognizing the importance of trusting in God as we develop new programs to engage with our young families. We are always looking for new ideas and people to come in and share their talents with our kids. If you have ideas, please share them with one of our classroom teachers, Pastor Kristi, Lori Miller or Anna Sorensen.

The Busy Fingers were active in 2022 after the pandemic. We got some new members during the winter who were very active and good helpers! We are thankful for them!

During 2022 we donated 3 quilts to the Knight of Knights fundraiser for our A-C School. The sale of the 3 combined earned \$145 for the school.

We met twice a month Jan through mid-May and donated 61 quilts to Lutheran World Relief on May 14, 2022. Previous to this, we offered the quilts to the congregation for sale and earned \$445 through that with the sale of several quilts. This fall we again offered the quilts to the congregation with one being sold for a total of \$60.

We also contributed to the Dress a Girl International program with approximately 90 dresses being made throughout the year. Our own Darlene Sorenson made the majority of these dresses. We did not participate in the Christmas Shoebox Project in 2022 as we have done in the past.

We are funded through Thrivent as well as through the sale of these quilts. We are eligible for 2 Thrivent gift cards per year for \$250 for each card. In addition to buying materials for quilts, we also donated approximately \$100 to the "Dress a Girl International" Project during 2022. We receive in-kind donations from the community and congregation such as sheets and pillowcases, old mattress pads, blankets, and bedspreads. We use what we have when we can and buy materials when we need them. Thank you for your donations!

Ann Purdy keeps busy making beautiful quilt tops for us! She does a wonderful job, and we appreciate her work! Some of us remodel sheets to back the quilts with. Others sew inner linings for the quilts. This is done on our own time. Trent Nelson sets the tables on risers for us prior to our meeting on Monday morning when three of us meet the day before quilting and get the quilts (backs, linings, and tops) set up for the next day. On the 1st and 3rd Tuesday of each month we meet as a group and tie the quilts and get them ready for sewing around the edge. Members take them home and sew around them at home or else with the churches' machines in the RLC basement. We are a well-oiled machine; we appreciate your donations of both materials and work! We urge all women who like to tie quilts to show up for quilting on the 1st and 3rd Tuesdays of each month. We meet from 9 am to 12 noon. We are not only doing a needed work by keeping God's children warm, we have a good time doing it. We do stop for coffee! You are welcome! Watch the bulletin for our meeting times!
