### **Details of Professional Experience:**

I commenced legal practice in 1996 and have over 25 years experience as a commercial litigator. I practiced as a solicitor for 6 years (1996-2002) and a barrister at the private bar for 15 years (2002 to 2017). In 2016 I was appointed as a quasi-judicial Member of the Administrative Appeals Tribunal.

Prior to my appointment at the AAT, I practiced in commercial law, with a specialty in intellectual property.

I have been recognised by solicitors and my peers as a leading or recommended junior counsel in the field of intellectual property (Doyle's Guide 2014, 2015, 2016, 2017, 2018).

In the five years I was a Member of the AAT I published more than 190 decisions, six of which have been appealed, none successfully.

In addition to my hearing and decision workload at the AAT, I also conducted directions hearings, case management hearings, various types of interlocutory applications and conciliation conferences.

Some of my decisions have been reported in the Administrative Law Decisions Reports and discussed in professional legal publications such as Weekly Tax Bulletin and Australian Tax Week.

My practice areas at the Bar are commercial law, administration law, tax law, workers compensation law, regulatory and intellectual property law. I also have experience in a variety of other fields such as social security, bankruptcy, higher education, and civil aviation.

Alternative dispute resolution is a major part of my legal practice. At the AAT I conducted conciliation/mediation conferences, primarily in taxation matters. I have represented parties at many mediations and acted as a mediator for commercial disputes concerning intellectual property, defamation, body corporate and general commercial disputes. In 2005 I completed the "Workshop for Mediators in Intellectual Property Disputes" at the Arbitration and Mediation Center at the United Nations (World Intellectual Property Organisation), conducted by academic staff from Harvard University.

### I became a Nationally Accredited Mediator in 2019.
