The tariff approved by the Commission shall be effective for the Electricity consumed from the first meter reading date falling on or after 01.04.2016. This Tariff is applicable to all the areas coming under the jurisdiction of HESCOM. Detailed Tariff booklet may be obtained from all Sub-Division offices of HESCOM on payment of prescribed price.
