THE VISION

- *TO ESTABLISH A FREE, OPEN AND STANDARDIZED ONLINE DIRECTORY OF INSTITUTION CODES AND IDENTIFIERS FOR USE BY EDUCATION INSTITUTIONS AND STAKEHOLDERS WORLDWIDE*

CURRENT STATE

- *A GLOBAL INSTITUTION CODE DOES NOT CURRENTLY EXIST*
- *COLLEGES AND UNIVERSITIES CREATE UNIQUE IDENTIFIERS FOR THEIR OWN USE*
- *PROBLEM INCREASING AS THE NUMBER OF INTERNATIONAL STUDENTS INCREASES*

THE CONSEQUENCES

- *EXCESSIVE COST TO MAINTAIN*
- *SIGNIFICANT DELAYS IN PROCESSING*
- *EXTENSIVE RISK OF FRAUD AND ABUSE*

- *ONGOING MAINTENANCE AND UPDATING*

- *FLAT LIST VERSION AVAILABLE FOR DOWNLOAD*
- *API SEARCH AND DOWNLOAD SERVICES*

DATA COLLECTION

- *COMPILE DATA FROM AS MANY SOURCES AS NECESSARY*
- *ELIMINATE DUPLICATION*
- *'ROLLING' COUNTRY DATA UPDATES*
- *DATA SOURCES VETTED AND RANKED BY QUALITY*
 - *MINISTRIES OF EDUCATION*
 - *TRUSTED COUNTRY BASED SOURCES*
 - *WIKIPEDIA*

- PHONE, EMAIL, WEBSITE
- LEGAL ENTITY TO WHICH INSTITUTION BELONGS
- SHORT INSTITUTION CODE

- VARIABLE # OF NATIVE CODES FOR EACH
