Andrew Deserto, Chief Deputy U.S. Marshal (acting)

Drew began his career with the United States Marshals Service (USMS) in 1998 after receiving his Bachelor's Degree in Accounting from the University of Delaware. After completing basic training at FLETC, Drew was assigned to the USMS Cleveland Office where he worked from 1998 – 2005. During this time he worked his way into full-time fugitive investigations, became a member of the USMS Financial Surveillance Unit, and was integral in the development of the Northern Ohio Violent Fugitive Task Force (NOVFTF).

In 2005, Drew promoted to the position of Senior Inspector with the USMS in Houston, Texas. In this position, his primary mission was to locate and apprehend drug cartel fugitives stemming from OCDETF (Organized Crime Drug Enforcement Task Force) investigations and to assist with the coordination of OCDETF investigation arrest operations.

In 2008, Drew was promoted to the position of Assistant Chief Deputy U.S. Marshal and returned to the Northern District of Ohio. In this position, Drew was the #3 in chain of command for the office and his primary responsibility was as Task Force Commander for the NOVFTF.

In 2015, Drew was temporarily promoted to Acting Chief Deputy which is the #2 in chain of command under U.S. Marshal Pete Elliott. He oversees all USMS operations for the Northern District of Ohio which encompasses 40 counties with main offices in Cleveland, Akron, Youngstown and Toledo. Drew is currently competing for the permanent Chief Deputy position which should be selected in May.
