The regular monthly meeting of the Town Council of the Corporation of the Town of Rainy River was held on Monday, September 11, 2023, at 5:30 p.m. in the municipal council chambers.

Presentations/Delegations

Riverside Foundation for Health Care

Allison Cox, the Foundation Director, and Paul Brunetta, the Board Chair, were in attendance to discuss equipment for their facility in Rainy River.

Since they were established in 1987, they have put 12 million dollars' worth of equipment into the facility through public donations. The foundation has now received a request from Dr.

Ennett regarding a new ultrasound for Rainy River. It was noted that during the pandemic more ultrasounds were being done in Rainy River (about 500 per year). The old machine does not take pictures as good as the newer models and is doing work that it was not intended for.

Approximately \$20,000 in donations have been received thus far, and another \$20,000 from the hospital auxiliary. The new machine costs about \$135,000. Riverside is asking the Town of Rainy River for \$5,000. Other townships have also been asked to donate that amount as well as New Gold and West Fraser.

Following the presentation, the delegates left the meeting at 5:50 p.m.

Council would like to bring a motion forward at the next meeting to approve a \$5,000 pledge for the 2024 budget year towards the purchase of this ultrasound.
