The Solution To My Problem Isn't Me

Principle of this Step: Hope

Reading Assignment: BB pgs: 44-60/ 12&12 pgs. 25-33

What Can I Surrender in this Step?

My desire to control everything myself, and
My belief that I am responsible for the outcome of my life

TRADITION 2

Long form: "For our group purpose there is but one ultimate authority- a loving God as He may express himself in our group conscience."

TRADITION 2 EXPLAINED

Below is a snapshot inventory you can take to see how well you are honoring the spiritual principle found in this Tradition (in and out of the rooms of AA)

- 1.Do I criticize or do I trust and support my group officers, AA committees, and office workers? Newcomers? Long-timers?
- 2. Am I absolutely trustworthy, even in secret, with AA Twelfth Step jobs or other AA responsibilities?
- 3. Do I look for credit in my AA jobs? Praise for my AA ideas?
- 4.Do I have to save face in group discussions, or can I yield in good spirit to the group conscience and work cheerfully along with it?
- 5. Although I have been sober a few years, am I still willing to serve my AA chores?
- 6. In group discussions, do I sound off about matters on which I have no experience and little knowledge?
- 7. Why is it necessary that a healthy relationship be in one which the members are equals?
- 8. How do you feel and react when someone tries to or dominate in your relationships?
- 9. Do you have an inherent tendency to dominate people around you? How can you correct this defect of character?
- 10. Are you someone who is always willing to allow someone else to take control and then complain because you don't like what was done, yet were unable to make a decision yourself?
- 11. What is the difference between suggestions, advice, and guidance?
- 12. Is God or a Higher Power the only authority in your relationships? How does this Higher Power express Himself to you when making any decisions?
- 13. Why is it necessary to give the minority opinion in an open-minded evaluation in a group conscience?
- 14. Why is humility a necessary ingredient in applying Tradition 2 to your relationships?

STEP SUMMARY

In Step 1, we learned out problem wasn't alcohol- it was/is our mental states (our thinking) that was the crux of the real problem. How perfect it is that just 10 pages later (page 45, "We Agnostics"-4th Edition), Bill shared with us the solution to that problem. "Lack of power, that was our dilemma. We had to find a power by which we could live, and it had to be a Power greater than ourselves. That's exactly what this book is about. Its main object is to enable you to find a Power greater than yourself **which will solve your problem**."

Check! How simple is that? This one of the twelve steps suggestions is much easier than I ever imagined. I thought solving the drink problem was going to be insurmountable. When I figured out that it's not a drink problem I need to solve, but a think problem- and that simply believing there is a Power out there that is greater than I am that can help me solve it- well, that made life much easier to bear.

I then get to ask myself why I shouldn't apply to life's problems the same readiness to change my point of view. I was having problems with relationships, couldn't control my emotions, was prey to misery and depression, couldn't make a living, had a feeling of uselessness, was full of fear, was unhappy and couldn't be of help to others. I was/am "maladjusted to life, in full flight from reality and an outright mental defective" (BB- Doctor's Opinion- page xxvi- 4th Edition). All of this was true until the day came I could finally believe that a power greater than myself could run my life better than I could- and all I had to do was let it.

CONCEPT 2
