The law regarding 50% payment upfront has changed and this can now be done. Councilor Benson offered a friendly amendment that approval is subject to Attorney Nolan's review and approval. Councilor Norkus accepts the amendment. Unanimously approved.

Councilor Benson motioned to accept quote from Meyer Glass of June 19, 2023 for \$19,258.65 to be paid out of the ARP Fund subject to Attorney Nolan's review and approval. Councilor Norkus seconded. Councilor Norkus offered a friendly amendment that this is subject to confirmation that the quote is still valid. Councilor Benson accepted. Unanimously approved.

Grants updates: Councilor Norkus gave report. The Lake MI Coastal Grants full proposal is due on January 12, 2024. It is being prepared and submitted by the Smith Group. The Lake & River Enhancement grant proposal is due by January 15, 2024, which will be prepared similarly. Norkus is meeting with GLSLCI along with Phelps. Councilor Benson motioned to approve first annual subscription dues of \$412.50 (25% discount from \$550) to be paid from the ARP Fund. Councilor Malik seconded. Unanimously approved. There was a consensus to have Susan Loeb and Andre Daugavietis continue as representatives with Cities Initiatives.
