KIFA's 60th Anniversary Open Judged Art Show - 60 Square Inches & 60 Parts, 60 Strokes, or 60 Words

August 3rd through October 25th, 2022

This is a judged show of works in the following mediums: Oil & Acrylics, Water Media (watercolor & gouache), Graphics (printmaking, drawing), Mixed Media/Collage, Sculpture and Literary works.

Artists may enter only one piece.

Guidelines: Use 60 Parts, 60 Strokes or 60 words to create your Artwork. All work must be original, created within the last three years, **not previously shown at KIFA** and must not infringe upon any copyright. Reproductions are not accepted. Sculptures must include their own base or fit on a KIFA pedestal. Sculpture artists must be prepared to assist in placing their work in the gallery. Size including base is: 60" high x 1" wide and deep, or 60 cubic inches. **2-D works must be dry, suitably framed, wired and ready to hang. No saw-tooth hangers.** (Artwork not wired properly will not be accepted.) Size of artwork image without the frame is to be 60 square inches, can be 2"X 30", 5"X 12", 6" X 10" etc. All works on paper under glass, should have no exposed edges. We will accept sealed water media without glass.

KIFA does not discriminate against anyone and encourages diversity in all works that KIFA's Gallery Committee deems is suitable for the public to view. All entered works must remain on display through the end of the show. Reasonable care will be taken to ensure the safety of your artwork. KIFA is not liable for loss or damage to artwork.
