PHYSICAL DEMAND AND SAFETY REQUIREMENTS

Cosmetology

- **Body Position: Long periods of time standing are required**

Nail Care

- **Body Position: Long periods of time sitting are required**

Skin Care

- **Body Position: Required to sit and lean forward while providing most of services; Required to stand and lean forward for other services**

All Programs

Sanitation:

Communicable disease can be easily transmitted from one individual from one individual to the next. Special attention must be paid to yourself and your client to avoid spreading any disease.

Hands:

The hands will need protection from chemicals and continuous exposure to water and cleaning agents. Hand care products are recommended for all service professionals.

Chemicals:

In this industry, you will be required to work with many different types of products and chemicals. If you currently have allergies or sensitivities to chemicals, please consult your physician with a list of chemicals you will be exposed to.

Tools:

There are obvious hazards when working with sharp objects such as scissors, razors, clippers, extractors. Caution must be used when handling any of these items.

General Safety:

Daily use caution to avoid any of the following situations: Cuts, Abrasions chemical burns, harmful vapor, excessive heat from hair dryer etc.

California State Board of Cosmetology License Information

To obtain a cosmetology license in California from the California State Board of Barbering and Cosmetology in Cosmetology, Esthetician and Manicurist, students must complete the California State Board of Cosmetology requirements listed below.

Board of Barbering and Cosmetology License Requirements:

- COSMETOLOGIST: 1600 hours
- ESTHETICIAN (Skin Care) : 600 hours
- MANICURIST (Nail Care):400 hours

Qualifications to take the Board of Barbering and Cosmetology (Board) exams:

- **Be at least 17 years of age.**
- **Has completed the 10th grade in a public school or its equivalency**
- **Has committed no acts or crimes constituting grounds for denial of licensure under Section 480 of the Business and Professions Code.**
- **Has completed the following hours in a Board approved school or has completed a 3200 hour apprentice program in California**
