AN ORDINANCE ESTABLISHING A NEW SCHEDULE OF FINES FOR TRAFFIC AND NON-TRAFFIC VIOLATIONS FOR MAYOR'S COURT IN THE VILLAGE OF RUSSELLS POINT, OHIO

WHEREAS, the State of Ohio has mandatory court costs to be submitted through the Reparations Rotary Reporting to fund the state's public defender's office, and

WHEREAS, an increase in Mayor's Court fines has not occurred since 2014 and adjustments to costs are needed to be in line with neighboring courts, and

WHEREAS, Mayor's Court is established to protect the health, welfare, and safety of the public.
