A motion to approve the 2016-2017 Budget as proposed was made by Council member Goodwin and seconded by Council member Reed. The motion carried (6-0).

A motion to approve the Library Board's recommendation to appoint Donna Parr to the Library Board was made by Council member Goodwin and seconded by Council member Gates. The motion carried (6-0).
