Josh was recognized for finishing second in the State of Illinois. All gave comments about how this honor affected them and congratulations were shared by all.
- 2. Rendy Pierson-Stephens, Manager of the local McDonald's was recognized for her fundraising efforts in the amount of \$5,165.00 for the Ronald McDonald House in Springfield, Illinois.
- 3. Havana Jaycee Chapter President Zach Bryant along with Jaycee members Chris Boggs and Jeanna Clancy were recognized for the state awards they had received for outstanding new President, chapter and for projects that they had completed such as the first Trivia Contest. Due to illness representatives from Bath, Kilbourne and Manito were unable to attend but those that were there from within the County exchanged information and enjoyed having time to get to know each other in an informal setting.
