To the Sherburn and Welcome City Councils,

The department logged 135 calls for service for the month of March. This brings the total for the year to 692. In comparison, the department stood at 773 for the year in 2014 and 529 in 2013 for the same reporting period.

Response time for the month averaged 2 minutes and 15 seconds. This is about average for the department in comparison to past months.

The department again put on the elementary school law enforcement event in Sherburn on May 1st. Each department from the county was represented at the event including Fairmont, Trimont, Truman and the Sheriff's Office as well as the Minnesota State Patrol. This year, two representatives from the ERU (Emergency Response Unit) were also present and brought along a number of the tools that they use in the performance of their duties. They also did a demonstration of a "flash-bang" grenade for the kids which was a big hit. All of the kids had fun and I believe the officers did as well. This event is done each year in recognition of National Law Enforcement Week.

The deadline for property clean-up was May 4 and properties receiving a tag in April will be rechecked during the first week of May to see if there are still any violations that need attention. Those who are still not in compliance will be issued citations for the offense.
