The Regular meeting was opened at 7:10 pm.

Allan read Resolution No.5 on 102nd Ave the Al Pertelle development.

We had petitions of 50% of property owners in the district for this Special Assessment District Requesting water and sewer. This Resolution states that the Supervisor submitted a special assessment roll and proper notice was given to property owners to establish this SAD and the Township clerk is directed to endorse the assessment roll the fact the roll has been confirmed. B&Z from St. Joe was the successful bidder in the amount of \$420,084.00.

Allan read Resolution No. 5 on SAD 102nd Ave. for water and sewer.

Resolution No. 5

WHEREAS, by resolution passed on March 21, 2016, it was determined that the Supervisor Should prepare a special assessment roll covering and including the parcels of land described In said resolution;

WHEREAS, the Supervisor submitted a special assessment roll, report and certificate in Accordance with the instructions specified by this Township Board; and

WHEREAS, the Township Board did, on the receipt of such items, by resolution adopted March 21, 2016, at 7:00pm., local time at the Casco Township Hall, located At 7104 – 107th Avenue, South Haven, Allegan County, Michigan, as the time and place for a Public hearing to review and hear any objections to the special assessment roll; and

WHEREAS, proper notice of said hearing was given by publication and mailing, all in Accordance with the terms and provisions of Act 188, Act 162, and Act 64; and

WHEREAS, the Board did meet at the time and place of said public hearing to review the Special Assessment roll and hears any objections and other matters related to the special Assessment roll;

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

 That the special assessment roll prepared and submitted by the Casco Township Supervisor, With amendments or corrections made, if any, by this Board, for Water and Sewer Special Assessment District No. 2016-01, including the lands described in the Notice of Hearing for this special assessment roll, in the amount of \$420, 084.00, plus the Township's Costs of establishing the special assessment district, for the purpose of defraying the cost Of constructing water and sanitary sewer improvements as are described in the Notice of Hearing on this special assessment roll, be and the same is hereby ratified, confirmed, and Adopted. The Township Clerk is hereby directed to endorse on the assessment roll the fact the roll has been confirmed as of the date of this meeting.

- 2. That the special assessments contained in said special assessment roll shall be payable in 15 or less equal principal and interest installments, or in full at any time with interest accrued through the month in which the final installment is paid.
- 3. That the first principal and interest payment shall be due on February 14, 2017. The Remaining installments shall be due on February 14 in each and every year thereafter, Through February 14, 2017.
- 4. That all unpaid installments, prior to their transfer to the Township tax roll as is provided In Act 188, shall bear interest, payable annually on each installment due date, at a rate of _3%__ percent per annum from June 1, 2016.
- 5. That all resolutions in conflict herewith in whole or in part are hereby revoked to the Extent of such conflict.

Allan asked for public input about the tress that were cut and he also gave history about the Bluff area belonging to the Township. There seems to be a lot of concern about the bluff. Suggestions on how to fix the problem and take the comments and recommendations to the board on how to handle the bluff area.

Rene Garrity, Glenn Shores, would like to see the dead ash trees cut but leave a 10' stump. The board approved getting a quote to cut these trees.

Dave Campbell, Glenn Shores, said on Orchard Rd that there are some trees hanging over the road. Allan said he would look into that with the Road Commission. Bids for the extra parking at the Preserve are due 4/28/16.
