#### APPROVAL OF MINUTES

The Road and Bridge bills for \$68,804.45 were read. A motion to approve the bills as read was made by Trustee Cox and seconded by Trustee Hopkins. Roll call found the vote unanimous on the motion to pay Road and Bridge bills for \$68,804.45. Motion carried.

The Town fund bills for \$85,232.01 were read. A motion to approve the bills as read was made by Trustee Hopkins and seconded by Trustee Royer. Roll call found the vote unanimous to pay the Town fund bills for \$85,232.01 Motion carried.

# **UNFINISHED BUSINESS**

Ms. Nina Lindhorst and Ms. Lynne Kerfoot representatives for the Y.M.C.A. reported on this past year of tutoring children after school. They reported that Dorris School wants to participate in the program this year also. The ladies feel they can include them without increasing expenses. So the Y.M.C.A. is again requesting a donation of \$14,000.00. A motion was made to donate \$14,000.00 to the Collinsville Y.M.C.A. for after school tutoring of Unit 10 students by Trustee Hopkins and seconded by Trustee Cox. Roll call found the vote unanimous. Motion carried.

Next, Senior Center Director, April Hausman, questioned if the board had decided on her 30/70 split for her exercise classes. Attorney Daugherty advised he appreciated the simplicity of the agreement she wrote however the agreement has to cover other issues also. Trustee Hopkins suggested Attorney Daugherty and Director Hausman write up an agreement and the Board vote on it. Jack suggested she check other Townships and how they do it. Trustee Foley suggested we pay her \$35.00 a month license fee. A motion was made that Attorney Daugherty and Director Hausman make an agreement between the Township and April and the 30/70 split by Trustee Hopkins and seconded by Trustee Foley. Roll Call found the vote unanimous. Motion carried. The last item under unfinished business was the Resolution to Dissolve C.A.R.D. A motion was made by Trustee Hopkins that we approve The Resolution to Dissolve C.A.R.D. Trustee Royer seconded the motion. Roll call found the vote to be 4 ayes and one no. Trustee Foley voted no. Motion carried.

### **NEW BUSINESS**

A motion was made to table voting on one meeting a month. The motion was seconded by Trustee Royer. Roll call found the vote unanimous. Motion carried

A motion to approve the IPPFA Deferred Comp Plan (457 Savings Plan) was made by Trustee Foley and seconded by Trustee Cox. Roll call found the vote unanimous. Motion carried.
