# Missouri-7 Absentee Options

Registered Missourians who expect to be prevented from going to their polling place on Election Day may vote absentee beginning six weeks prior to an election.

Absentee voters must provide one of the following reasons for voting absentee:

- 1. Absence on Election Day from the jurisdiction of the election authority in which such voter is registered to vote;
- 2. Incapacity or confinement due to illness or physical disability, including a person who is primarily responsible for the physical care of a person who is incapacitated or confined due to illness or disability;
- 3. Religious belief or practice;
- 4. Employment as an election authority, as a member of an election authority, or by an election authority at a location other than such voter's polling place;
- 5. Incarceration, provided all qualifications for voting are retained.
- 6. Certified participation in the address confidentiality program established under sections 589.660 to 589.681 because of safety concerns.
- For an election that occurs during the year 2020, the voter has contracted or is in an at-risk category for contracting or transmitting severe acute respiratory syndrome coronavirus 2 (COVID-19).

Voters who are considered at-risk for contracting or transmitting COVID-19 are those who:

- Are 65 years of age or older;
- Live in a long-term care facility licensed under Chapter 198, RSMo.;
- Have chronic lung disease or moderate to severe asthma;
- Have serious heart conditions:
- Are immunocompromised;
- Have diabetes;
- Have chronic kidney disease and are undergoing dialysis; or
- Have liver disease.

Voters can request absentee ballots from their local election authority in person, by mail, by fax or by e-mail. Relatives within the second degree (spouse, parents and children) may complete an absentee ballot application, in person, on behalf of the voter who wishes to vote absentee. DO NOT SEND ABSENTEE BALLOT APPLICATIONS TO THE SECRETARY OF STATE'S OFFICE. ABSENTEE BALLOT APPLICATIONS MUST BE SENT TO THE APPROPRIATE LOCAL ELECTION AUTHORITY BY THE DEADLINE IN ORDER TO BE VALID. 
In-person voting begins six weeks prior to each election. Absentee voting for the November 3 General Election will be available in the **Innovation Room (Suite** 100) on Level B of Union Station from 8:00 a.m. to 5:00 p.m., Monday through Friday starting September 22, 2020. Absentee voting is also open the Saturday before each election from 8:00 a.m. to noon.. Attention Absentee voting for the November 3 General election WILL NOT BE LOCATED IN the Election Board office (Suite 2800- level B). Please bring identification with you when voting in person. The deadline to vote absentee inperson is 5:00 p.m. the Monday before each Election Day.

Census Takers Will Follow Up Nationwide Through September 30

Census takers will continue to follow up in-person with homes across the country through September 30 in an effort to reach everyone.

**December 2020**: The Census Bureau will deliver apportionment counts to the President and Congress as required by

**March 31, 2021:** By this date, the Census Bureau will send redistricting counts to the states. This information is used to redraw legislative districts based on population changes.
