#### Nomenclature

Mathematical expression should be formatted in a column width of 55 characters. Mathematical expressions will be typeset exactly flush with the right margin. Number that identifies mathematical expression should be enclosed parentheses.

#### References

References should be typed doubled-spaced, arranged in numerical order as given in the text and on a separate sheet. Journal references should be given

in the following order; author, article title (with subtitle, if any), journal abbreviation, volume number in Arabic numerals, inclusive pages and year. If the paper has been seen only in abstract, this should be indicated at the end of the original reference by the addition of abbreviation (Abstr.), followed by the name, volume, pages and year of abstract journal. The order for the book references is as follows: author title, volume (if more than one), edition number (if other than the first), city, publisher and year. If the reference is a chapter in a book, the order changed as follows: author of the chapter, title of the chapter, "In," book title, volume, edition, editors, city, publisher, year, and inclusive pages of the chapter. See the following examples:

Reference should be referred to by numbers in text, and be listed in numerical order at the end of the paper. Authors are responsible for bibliographic accuracy and must check every reference in the manuscript and proof read again in Page proof.

#### **Tables**

Tables should be numbered consecutively with Arabic numbers in order of appearance in the text. Also type each table double-spaced on a separate sheet. Do not use vertical rules. Supply short descriptive title above the tables.

### **Figures**

Must be camera-ready specified, Original & three copies of figures must be accompany the manuscripts.
