

#### West Hawaii Health Fair



The West Hawaii Component participated in the health and dental health fair that was held in conjunction with the Ho'okuikahi I Pu'ukohola 2010 Celebration at Pu'ukohola Heiau held August 12-15. This event celebrated the restoration of the heiau and the 200th anniversary of the Kingdom of Hawaii that began at the heiau.

For many native Hawaiians, this is the only opportunity for health screening and physician counseling. Over 2 days during the event, cholesterol and blood sugar screening, diabetic and nutritional counseling, keiki and adult dental screenings and education were

provided. Approximately 50 health care professionals participated from agencies which included Hamakua Community Health Center, West Hawaii Community Health Center, North Kohala Hospital, West Hawaii Hospice, Papa Ola Lokahi, John Burns School of Medicine and private practice physicians, dentists and hygienists.

Children and adults were screened by volunteer dentists on the Amazing Tooth Bus which is a mobile dental care van. Hygienists Diana Smith, Donna Altshul and Sierra Spruce (pictured above) assisted with intake and education. Many of you may remember seeing this mobile dental van at the ADA convention last October.

#### **REPORT FROM LAS VEGAS - ADHA'S ANNUAL SESSION**



Your Hawaii Delegation was comprised of Gayle Rubino, Ellie Kelley-Miyashiro, President Tricia Jinbo, and Sierra Spruce (pictured at left.) The delgation arrived in Las Vegas early in the morning on June 23rd and found we could not get an early check in. So a little retail therapy was in order to shake off the jet lag.

This year's combination of the Center for

Lifelong Learning (CCL) and the 87th Annual Session Business Meeting was a huge success, with about 1900 attendees. The first four days were packed with well attended CE courses. Tricia and Ellie volunteered to be facilitators for the courses and were very busy and very tired by Saturday. There were great plenary speakers and even a morning appearance by Cher, or someone who looked very much like Cher. It was great to see Dr. Esther Wilkins attending again and for a lady in her nineties, she danced and fully participated in every social event she attended. Besides being a mentor for many hygienists, she is a great role model for aging well.

Hawaii was well represented at the Student Table Clinics and Research Poster Sessions by four students from UH who presented two clinics. A community service day was held at a local high risk Elementary school with hygienists able to donate their time providing oral health education. Our own former District XII trustee, Caryn Solie, was installed as the new ADHA President.

Probably the two most inspiring sessions we attended were the Mega Issues Forum where hygienists from across the country brainstormed the hottest topics for the hygiene profession

and the Legislative Workshop, where Minnesota State Senator Ann Lynch was our speaker. She championed legislation in her state that established the first "mid-level" dental providers.

Resolutions and by laws changes presented by ADHA councils, Board of Trustees, Districts and States are discussed in District meetings and reference committees. Sometimes, even with all of the prep work, the House of Delegates discussions and voting can go longer than expected as we found out Monday night, when we were there until 10 PM. Below are some of the important issues voted on by the HOD:

Proposed Resolution 2 - The following definition was adopted; Mid-Level Oral Health Practitioner: A licensed dental hygienist who has graduated from an accredited dental hygiene program and who provides primary oral health care directly to patients to promote and restore oral health through assessment, diagnosis, treatment, evaluation and referral services. The Mid-Level Oral Health Practitioner has met the educational requirements to provide services within an expanded scope of care, and practices under regulations set forth by the appropriate licensing agency.

Proposed Resolution 7 - The following definition of Professional Autonomy was adopted:

A profession's authority and responsibility for it's own standards of education, regulation,
practice, licensure and discipline.

Most of the other resolutions voted on were to clarify or update language of various policy statements in our association policy manual. If you have not attended the ADHA Annual Session before, I urge you to attend. It's where decisions are made for the future of your profession! And...the fellowship with hygienists from other states is phenomenal. Next year's meeting is in Nashville from June 15-21, 2011. Don't miss it!!



## A New Approach to Community Outreach in Hawaii: "Sweet Sex Appeal"

It is no secret that I am a fan of Trisha O'Hehir, RDH, MS. Early in the 1980's, I was drawn to her regular Perio column in RDH Magazine. Every month, I devoured her words and applied them to my practice, as a Periodontal Therapist. To this day, her publication of PerioReports has kept me current and knowledgeable. After teaching advanced instrumentation together at NAU, Trisha and I became good friends. Her work has shaped and molded me into the professional that I have become. She continues to influence and inspire me. Last year, I had the honor of acting as her room host at ADA, and every course was packed with her fans. She was so popular, HDA invited her back for their convention, where she gave four new cutting edge courses. The following success story is dedicated to my A#1 mentor... Trisha O'Hehir, RDH, MS.



Kaika, a young mother who operates the nearby Dragon's Eye Community Learning Center, called me recently, to ask if I could come and give a workshop on a Saturday morning. (Picture is of "The Big House" at DECLC.) Since she, and so many of her associates, really could not afford to go to the dentist, she wanted me to teach them how to clean each other's teeth. You can guess my answer. However, I did offer to share ways to save a lot of money through prevention of future disease. We scheduled three hours on an upcoming Saturday morning and Kaika was thrilled

As soon as we hung up, I set to work on the program: "The Sweet Truth: Save Your Teeth/Save Your Life!" As I worked, I could hear Trisha O'Hehir's voice reminding me that people value sex appeal more than health, and I planned the course accordingly. Days later, 85 slides were finished and I thought I would speak for about two hours and have Q and A. My plan was to discuss bacterial biofilms; periodontal infection; systemic links; caries infection; halitosis; white teeth; and xylitol. My husband insisted that no one would want to hear this "boring stuff", so I banned him

from the program, to save him the distress.

Dragon's Eye Learning Center is a large community farm with several simple buildings and a huge hydropontic greenhouse and pond. Kaika greeted me with her sweet little one, Ili, who was quick to tell me that she used "floss and a thingy that squirted water between... (her)... teeth everyday!" No wonder she was going to the beach! She had prevention down already!

Deep in the rainforest, the classroom building was open air, with a metal roof. Luckily, the sun was shining, so I would not have to complete with the sound of pounding rain. The "screen" was a made of wood and painted white. The LCD projector hung from the rafters above. S step stool held my computer. Twenty enthusiastic attendees gathered on three long. soft couches that faced the screen, accompanied by several wooden chairs.

When I asked why people had come, I found the full gammit. There was a young man already losing teeth to periodontitis; an older Hawaiian man with diabetes, "soft teeth, and a mouth full of fillings and loose teeth," who wanted to learn how to strengthen his teeth; one woman was there because her gums were

receding and her teeth were sensitive. She wanted to know how to prevent the sensitivity; finally, there were parents there with five year olds who had early childhood caries.

Conscious of my husband's words, I watched for someone to asleep, but no one did! In fact, the audience was leaning in and the questions kept coming! I kept finding myself saying:

#### "I'm glad you asked that! We're gonna talk about that!"

We had activities, too! We did the Eastman Periodontal Index; passed around a probe; tested saliva pH; scraped tongues and checked for halitosis; evaluated the whiteness of teeth; played with power brushes; and ate xylitol candy. We had TERRIFIC FUN for FOUR hours without even taking a break! When I was finished, they continued to sit and listen to more questions and answers, in spite of the fact that I would not be giving them a



course code for continuing education credits! This audience WANTED to be there and could not believe that four hours had gone by so quickly. The feedback was wonderful, as one by one, they communicated a deep appreciation and shared how this would make such a difference in their health and their family's health. They believed that they finally had "the whole story", and understood how the pieces of the puzzle went together.

When my husband ran into three of the attendees at different times, he got an earful about all they had learned and how much they loved the course. My husband said to me, "Who would've guessed?" I said, "Certainly not you!" and we both laughed.

For a long time, I have thought about doing a course like this, but I was not convinced that there would be an interest. I am grateful that Kaika motivated me to put this course together for the lay public. Now that I know there is an interest, I will be taking this course to other communities to plant seeds of sex appeal, wellness, and prevention. People are so excited to hear that when they attack bad breath and yellow teeth, they get the benefit of disease prevention and saving money! Who would've imagined it could be so simple? Hawaii has one of the highest decay rates in the country. It's time for that to change. ~ Diane Brucato-Thomas, RDH, EF, BS, FAADH
