The Jewell County Commissioners, Steve Greene, Dwight S. Frost and Mark Fleming met on Monday, November 14, 2016 at 8:00 a.m. as the Board of County Canvassers, to canvass the ballots from the November 8, 2016 General Election. Carla J. Waugh, Jewell County Clerk/Election Officer was also present.

The ballots for the General Election were canvassed with 34 provisional ballots reviewed and 25 deemed valid and counted.

The Board of Canvassers recessed at 9:05 a.m. until 9:30 a.m.

The canvassing was completed and the board adjourned at 10:45 a.m.

COMMISSIONERS PROCEEDINGS  
November 14, 2016

The Jewell County Commissioners met November 14, 2016 at 9:05 a.m. with Commissioners, Steve Greene, Dwight S. Frost and Mark Fleming present. Carla J. Waugh, County Clerk was also present.

Jenny Russell, Jewell County Economic Development, reviewed the Dane Hansen Clean-Up Grant requirements.

Ivan Frost suggested that the school bus route should be the first roads bladed for snow removal.

Joel Elkins, General Superintendent, reported on road & bridge maintenance and discussed personnel. The Commissioners reported road and bridge concerns. Joel Elkins discussed purchasing another motor grader from Foley Equipment at the same bid price as one purchased earlier in this year. Dwight S. Frost moved and Steve Greene seconded the motion to purchase the 2016 Caterpillar model 120M2AWD Motor Grader for a total of \$260,533 from Foley Equipment. Motion carried.

The Commissioners recessed at 9:30 a.m. to complete the canvass. They reconvened at 10:45 a.m.

The minutes of the November 7, 2016 County Commissioners meeting were approved.

Don Jacobs, Sheriff, discussed the heating/cooling system in the sheriff's office. He provided an update on the operations of the office.

Carla J. Waugh left the meeting at 11:10 a.m. and Shena Mizner, Deputy County Clerk, joined the meeting to take the minutes.

Angela Murray, Health Nurse, reported on faulty electrical outlets in her office. Angela also discussed replacing one of her department's cars. Angela had the following bids for a new vehicle:

Mark Fleming moved and Dwight Frost seconded to accept the bid from Beloit Auto & Truck Plaza for a 2017 4X4 Jeep Cherokee for \$24,958. After discussion, Mark Fleming voted to accept the bid. Steve Greene voted against the motion. Dwight Frost abstained. Motion failed

Steve Greene moved to accept the bid from Beloit Motors for the 2017, FWD GMC Terrain for \$23,100. Dwight Frost seconded. Motion passed unanimously.

Angela Murray, Health Nurse, also discussed advertising the current vehicle for bids.

Dwight S. Frost moved to appoint Kendall Nelson to the Hospital Board. Steve Greene seconded. Motion passed unanimously.

The meeting was adjourned at 11:44 a.m.
