I Call To Order and Introductions/Roll by Olson Olson called the meeting to order at 12:01 pm.

II Approve Agenda

Croghan moved and McClain seconded approval of the agenda. Approved unanimously.

III Approve Meeting Minutes - Leadership Committee March 11, 2020 Croghan moved and Peterson seconded approval of the minutes from the Leadership Committee Meeting on 03/11/2020. Approved unanimously.

VI Mission Critical Actions/Updates

 Membership Renewals for 2020-21: fee schedule and renewal packet materials

Buckton and Albers reviewed the draft membership renewal materials and plans with the group. Discussion included likely transitioning the RSAI Regional Meeting to be virtual meetings rather than in-person, in light of the COVID-19 social distancing requirements. A motion was made by NoII to approved the dues fee schedule for 2020-21 with no changes. Second by McClain. Approved unanimously. The dues mailing is anticipated to be finalized by May 20th. Final documents will be shared with the Leadership Group at its next meeting.

Continuous Learning and Equity Issues for Rural Districts – what are you
doing to serve students, what have you learned, does this experience inform
our future policy work at regional meetings or at the statehouse?

The group discussed various ways they are serving students in their local districts in light of school closures due to COVID-19, as well as challenges and

issues they are experiencing. General themes were discussed around the following topics:

- Inequities of access to high speed internet connection for students and staff
- Ensuring sufficient access to devices for students and staff
- Credit recovery and graduating seniors
- Commencement challenges
- Ensuring adequate notice for any future closures
- Challenges for reopening and health risk for school personnel in at-risk health categories (bus drivers, food service staff, custodians, etc.)

The group requested a letter be prepared on behalf to RSAI to the Governor and DE team to appraise them of some of these issues. Buckton will prepare and circulate to the Leadership Group for final input before submitting.
