As Discussed:

- ➤ Dennis Ratosky Sr. and Phillip Walters inquired of the ability to exonerate 177 Club Road from sewage billing without removing plumbing fixtures and still keep the tap for re-sale purposes. Water and electrical services has been terminated.
- ➤ Rules and regulations were reviewed: when your property is exonerated from sewage billing, the tap forfeits back to CMSA, and the authority will treat all customers the same.
- Tap to remain at 177 Club Road and invoicing and payments to continue.
- ➤ Charles Spaid representing LBSA requested quarterly reports on the allocation payments.

Engineers Report:

Solicitor Report:

As Discussed:

➤ Correspondence from Solicitor Barbin to Attorney Robert Petyak, dated December 18th, 2013, concerning John Shuniak tap in into CMSA sewer main. The board discussed this matter at length and came to the conclusion that there is no valid reason to treat Mr. Shuniak different than any other customer of the CMSA sewer system.

Plant Operators Report:

Plant operator monthly flow meter report was presented to the board.

As Discussed:

- ➤ High Street- during rain events the flows are higher coming from High Street Infiltration may be the cause of elevated flows.
- ➤ Penelec has checked the electrical connections from the plant to the electrical pole, loose ground wire on neutral.
- ➤ Corrosion of the lugs on the electrical connections on the main electrical panel on the CMSA side of the connections.
- ➤ CAMO has replaced the electrical contactor, for the number digester, which was blown due to electrical surge. Preformed infrared scan, found no major problems.
- ➤ CAMO to replace the corroded lugs in main electrical box, Penelec will be required to terminate power so service connections can be repaired, lugs are untreated against corrosion.
- ABJ Co., (preformed original installation), was unable to access the main control panel remotely, modem was bad, and ABJ Co. has no record of service history for the WWTP. Modem quote \$925.76, no warranty on this equipment.
- ➤ Modem for UV system (same modem for control panel) does not work either, probably was knocked out due to lighting strike at the WWTP in 2012.
- ➤ Plant operator to acquire more quotes on replacement modem for control panel, for discussion at the February meeting.
