Robyn Watkins made mention of the increased presents of the Sheriff's department in her area.

Chief Adams gave run numbers; total of 789 run, 671 EMS, 118 Fire. Two more lives were saves with the "Lucas" device that the fire department got with a grant, that is a total of 4 lives saved in 2 months. Fatal fire last month two unit did a great job on that fire. Seven fatalities this year in Franklin township and 21 working fires this year. 40 smoke detectors were installed last week and hydrant flushing starts next week, run your water to get the rust out.

Chief Welch said 10 computers need more memory, 8gigs of memory per computer is what they are looking at \$427.10. This will keep computers working better for a few more years. Chief Welch is still working on finding a solution to the fiber line with Time Warner/Spectrum that cost the township \$1000.00 per month. Chief Welch contacted Keytel for some quotes and will now reach out to Spectrum and see what they can offer. Engine 192 update, the paint shop found that parts were corroded by salt from the road not the accident. The back of the truck is not secure due to this corrosion. Estimate is \$5,048.00 for the repair. The board wants Chief Welch to see if Pierce would be willing to work with us on the price.

The engine needs picked up in Wisconsin, there are 3 options for the pickup of the engine. One fly someone out there to drive it back this option would cost over \$2,500.00, option two Pierce will deliver it to us for \$1150.00, option three Capital Towing will tow it back for over \$2000.00.
