Thunder Bay Cardiovascular Surgery Program

A good progress meeting was held with the engineers and the contractor for the Fifth Street and Atwood Avenue project. Some concerns were expressed regarding the drainage of Broadway Avenue – it is hoped that these issues can be addressed. Previously this road had no ditches and now there are ditches to drain the road.

The town also wanted to commend the town crew on a job well done on the culvert on River Avenue.

Property/By-laws/AMBIS – Councillors Pat White (Chair), Andrew Hartnell and Brent Helgeson

Some property items will be brought forward from the committee meeting at the in camera session at the end of this meeting.

It is hoped that the cat and dog by-law will be ready for review shortly. Councillor White noted that she had put a lot of information in the by-law in the hopes of covering all the bases and that council was more than welcome to remove any redundant or unnecessary items.

Economic Development/Tourism – Mayor Deb Ewald and Councillors Pat White, Andrew Hartnell and Martin Kreger

An offer was made to the Economic Development Officer candidate with a hopeful start date of August 15th. They would now like to set up a full committee meeting in this regard.

It was noted that the entrance signs for the town have arrived and they are looking to get them installed.

Beautification/Cemetery/Hannam Park – Mayor Deb Ewald and Councillors Larry Armstrong and Martin Kreger

Diana McGhee of MNRF will be in town on July 9th to do a walk-through of the accessible part of the trail in order to look at the drainage ditch and to discuss what kind of options may be available to make this municipal drain more appealing.

The Hannam Park Committee has met and it was reported that they made just under \$600 at the rummage sale. They are struggling to get performers for the August 25th art festival but it is still over a month away and they are hoping more will come forward.

Fire Board - Mayor Deb Ewald and Councillor Martin Kreger

A fire board meeting will take place on July 16th in Bergland. Mayor Ewald noted that she would not be able to attend but Councillor Kreger indicated that he would attend.

Recreation Board/Curling Club - Councillors Brent Helgeson and Andrew Hartnell

The Recreation Board had a meeting on July 9th with the new board members. Some of the outcomes of this meeting will include the Railroad Daze dance and ball tournament.

A meeting has been scheduled with the curling club for the afternoon of July 9th to go over some of the facility concerns they have brought forward.

Library Board - Councillor Andrew Hartnell

The Library Board has done a lot of fundraising. They will do an event during Railroad Daze but are close to meeting their fundraising goals. The board will not be having a meeting until the fall.

- 4. That if passed, the Clerk's Office notifies all school boards and municipalities in Ontario of the City of St. Catharines' initiative and encourage them to do the same."
