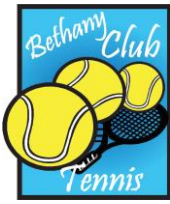

Disclaimer: **BETHANY CLUB TENNIS** is not responsible for any injury (or loss of property) suffered while participating in club activities, using equipment, traveling to club functions, participating in instructional programs, or on club premises, **for any reason whatsoever resulting from the ordinary negligence on the part of BETHANY CLUB TENNIS, its agents, or employees.**

In consideration of my membership or for being allowed to use the **BETHANY CLUB TENNIS** facilities and equipment today and on all future dates, I **hereby release and covenant not to sue BETHANY CLUB TENNIS**, its owners, its employees, instructors, independent contractors, or agents, **from any and all present and future claims resulting from ordinary negligence on the part of BETHANY CLUB TENNIS or others listed** for loss, damage, or theft of personal property, personal injury, or death, arising as a result of using the facilities and equipment of **BETHANY CLUB TENNIS** and engaging in any **BETHANY CLUB TENNIS** activities incidental thereto, wherever, whenever, or however the same may occur. I **hereby voluntarily waive any and all claims resulting from ordinary negligence**, both present and future, that may be made by me, my family, estate, heirs, or assigns.

Further, I am aware that tennis and sport fitness club activities may range from vigorous cardiovascular activity (e.g. playing tennis, instructional sessions, tournament play) to the strenuous exertion of strength training (e.g. free weights, weight machines). I understand that these and other physical activities at **BETHANY CLUB TENNIS** involve certain risks, including but not limited to, death, serious neck and spinal injuries, resulting in complete or partial paralysis, heart attacks, and injury to bones, joints, or muscles. I am voluntarily participating in club activities with knowledge of dangers involved and hereby agree to accept any and all inherent risks of property damage, minor or serious personal injury, or death.

I further agree to indemnify and hold harmless **BETHANY CLUB TENNIS** and others listed for any and all claims arising as a result of my engaging in club activities or any activities incidental thereto, wherever, whenever, or however the same occur. 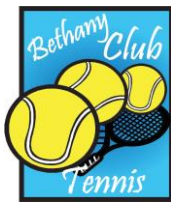

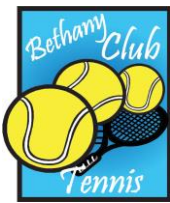

COURT ETIQUETTE

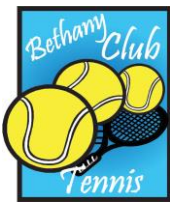
- As a courtesy to all members and guests when taking your assigned court(s), please do not walk across adjacent courts. All courts are to be entered and departed by the closest outside gate. When entering, please wait until the point is over and time is up before taking your court. When leaving, do not linger past your allotted court time while others are waiting.
- Players are expected to return stray balls to the correct courts as soon as possible.
- Members and guests are reminded that needless loud noise and improper tennis etiquette can be very disturbing to other players.

RULES AND REGULATIONS

- Members and guests must have "Good Standing" status to use any of Bethany Club Tennis facilities. A member or guest is considered to have "Good Standing" status when he/she has properly completed and returned his/her **BETHANY CLUB TENNIS** membership package, including all required signatures on the Release and Waiver of Liability and Indemnity Agreement. In addition, all membership dues, court fees and Pro Shop charges are to be current. Status is subject to review annually by **BETHANY CLUB TENNIS**.
- Weather permitting, courts are available for play and management reserves the right to cancel play at any time.
- Seasonal and weekly members may reserve court time in person or by phone 2 days in advance. **No phone reservations taken before 7am.** Daily non-members may reserve court time in person or by phone 1 day in advance. Court time booked by phone recording is acceptable; however if the requested court time is unavailable **BETHANY CLUB TENNIS** will contact you for an available time.
- Court reservations are 1 hour for singles and 1.5 hours for doubles.
- Each membership is granted 3 complimentary guest passes. **The host member must accompany their guests on the court and provide the guest pass filled out with guest details.**
- The host member is always responsible for his/her guests and fees.
- All guests and non-members are expected to follow Bethany Club Tennis rules, regulations and court etiquette at all times.

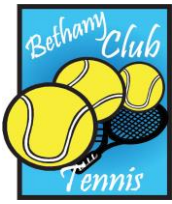

- Guest status may be terminated by **BETHANY CLUB TENNIS** at any time.
- **BETHANY CLUB TENNIS** enforces the 10-minute grace period. Members and guests must be fully registered and on the premises within ten minutes of their start time or the court is subject to re-assignment.
- Rain Policy: When play has been suspended or canceled due to weather conditions, **BETHANY CLUB TENNIS** will make every attempt to reassign court time to members and guests as available. However, as a policy, **BETHANY CLUB TENNIS** will not refund court fees.
- At the sole discretion of **BETHANY CLUB TENNIS**, courts may be reserved for special events such as: Tournaments, Exhibitions, Instruction, Group Play, and Club Activities. **BETHANY CLUB TENNIS** is authorized to implement temporary rules as may be necessary during any of the above activities.
- Junior members and guests under the age of ten must be accompanied by an adult for supervision unless otherwise permitted by **BETHANY CLUB TENNIS**. The upstairs observation and viewing deck is closed to unsupervised children under the age of 15.
- At certain times the courts may not be available due to maintenance requirements.
- Courts numbered one and five are designated instructional courts.
- **BETHANY CLUB TENNIS** courts are intended for the enjoyment of members and guests that have reserved court time to play tennis. Visitors, non-playing guests, and small children are not allowed to be within the fenced tennis court playing area at any time.
- Receptacles and water coolers are provided on the grounds and courts of the club. Please properly dispose all debris such as tennis ball cans, lids and paper cups.
- **BETHANY CLUB TENNIS** reserves the right to delete, alter or eliminate any rules, regulations, and policies at any time.
- Failure to follow these rules and regulations may result in a suspension or loss of membership privileges to play or participate in any **BETHANY CLUB TENNIS** activities.
- Proper tennis attire is to be worn at all times. Tennis shorts, shirts, skirts, dresses, tops, warm-ups, and tennis related t-shirts as determined by **BETHANY CLUB TENNIS** are permitted. No bathing suits, cutoffs, jeans or men's tank tops are allowed. Only smooth sole tennis shoes are permitted; both for safety and protection of the court surface.

Guest / Non-Member Policies

Prior to 1st play of the season; guests/non-members are required to complete a registration card

All guests/non-members must register at the front desk prior to scheduled court time

Definition of a guest: A non-member invited and accompanied on the court by a member
A \$25/session guest fee is applied (or a guest pass is used)

Drop-In events do not qualify for guest passes. Example: Men's Drop-In is \$25/person

A guest/non-member may only use a guest pass a total of 3 times.

Definition of a substitute: a non-member playing for a member.
A \$25/session non-member fee is applied (guest pass is not valid)

Guests/Non-Members are limited to 5 times per season

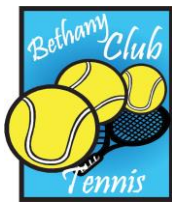
Definition of a session: 1 hour for singles and 1 ½ hours for doubles

\$15/person

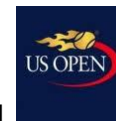
