ORDINANCE NO. 95

An Ordinance regulating the use of the municipal dump grounds and providing who may haul refuse and waste matter thereon.

BE IT ORDAINED by the City Council of the City of Rolla, North Dakota:

SECTION 1. It shall be unlawful for any person, firm, or corporation to haul, carry or transport to or dispose upon the municipal owned dump ground of the City of Rolla, any refuse, waste matters, ashes and cans or any other commodity or waste, without first obtaining a license therefore from the City Council of the City of Rolla in accordance with the provisions of this ordinance.

SECTION 2. The City Council of the City of Rolla shall from time to time adopt such rules and regulations concerning the use of the municipal dump grounds by a licensee as the council may deem advisable and in the interest of public health and a systematic use of said dump grounds.

SECTION 3. The holder of a regular dray license issued by the City of Rolla is hereby granted a special license without cost to use the municipal dump grounds of the City of Rolla, so long as such dray man shall comply with all provisions and regulations adopted by the City of Rolla from time to time with reference to the use of said dump grounds; provided, however, that such special license may at any time for cause be canceled and terminated by the City Council of the City of Rolla for violation of the terms of this ordinance or any of the rules and regulations for the use of said municipal dump grounds, without the cancellation of such license in any manner effecting the dray license granted such dray man.

SECTION 4. Any person other than a drayman may obtain a license under this ordinance for the hauling of his own refuse and waste by himself, by making application therefore to the City Council of the City of Rolla and by paying into the City Treasury an annual fee for such special license in the sum of \$10.00, and in such case with the approval of the Council, the City Auditor shall issue to such person a license, provided, however, that the City Council may for cause refuse to grant any such license, or if a license has been granted, the City Council may for cause cancel and terminate such license. The holder of any such license must comply with all of the rules and regulations adopted by the City Council for the use of said municipal dump grounds.

SECTION 5. The City Council may at any time cancel and terminate any license issued under the terms of this ordinance or the license of any drayman to use the municipal dump grounds for cause, after a hearing shall have been had before the City Council, to which hearing said licensee must be cited to appear and shall have at least twenty-four hours notice of such hearing.

SECTION 6. The City Council of the City of Rolla shall have the power to fix by resolution from time to time the maximum price which draymen licensed to operate under this ordinance may charge per load for hauling refuse and waste to the municipal dump grounds in accordance with the provisions of this ordinance.

SECTION 7. Any person or persons violating any of the provisions of this ordinance or any of the rules and regulations adopted by the City Council hereunder, shall upon conviction thereof, pay a fine of not less than \$5.00 nor more than \$25.00.

SECTION 8. All ordinances or parts of ordinances in conflice herewith are hereby repealed.
