To combat and respond to all the negative groups attacking law enforcement, PORAC is looking to hire a researcher who can set the record straight about police policies or conduct. (I.e. less than 1% of all police contacts result in force being used).

**Federal funding levels for law enforcement programs:**

1) **\$547.210 Million for Byrne Justice Assistance Grants compared to \$497 million FY 2019.** 2) **\$343 Million for Community Oriented Policing Services (COPS) grants compared to \$303.5 Million in FY 2019.** 3) **\$22.5 Million for body-worn camera programs. No change from FY 2019.** 4) **\$85 Million for assistance to victims of trafficking. No change from FY 2019** 5) **\$75 Million for the Stop School Violence Act.** 6) **\$378 Million for comprehensive opioid abuse reduction activities.** 7) **\$244 million for the State Criminal Alien Assistance Program.**

### ***Legislative Report***

**AB 855** (McCarty): DOJ Law Enforcement policies on the use of deadly force.

This bill would **require the AG to convene a task force**, as specified, to study the use of **deadly force by law enforcement officers and to develop recommendations**, including a model written policy, for **law enforcement agencies**. Furthermore, July 1, 2021, the bill will require the AG's office to **create a program within DOJ to review the policies on the use of deadly force of any law enforcement agency**. **PORAC Active opposes this bill.**

**AB 1599** (Cunningham): **Peace Officer Records Transparency**. This is an extension of AB 1421. Looks to go after officers accused of sexually assaulting a member of the public. Cunningham believes that if an officer resigns from his department before an investigation is done, there will be no investigation and the officer can be **hired by another agency**. **PORAC Active opposes.**

**Elevated Justice Act of 2020**  
**(Skinner):**

The act will rise the age of juvenile court jurisdiction to the age of 19, and further **protect public safety by addressing the risk and need factors of young people with the age appropriate intensive services within juvenile justice system. PORAC active oppose.**
