

RESOLUTION NO. 2019-05-13

A RESOLUTION OF THE BOARD OF ALDERMEN OF THE CITY OF TEAGUE, TEXAS, DECLARING THE RESULTS OF THE CANVASS FOR THE ELECTION RETURNS OF THE GENERAL ELECTION OF MAY 4, 2019 FOR THE PURPOSE OF ELECTING ~~A~~ THREE MEMBERS OF THE BOARD OF ALDERMEN, ALDERMAN PLACE II, ALDERMAN PLACE IV AND ALDERMAN PLACE V, FOR A TERM OF TWO YEARS.

WHEREAS, the Board of Aldermen of the City of Teague, Texas (City) held a General Election on May 4, 2019 for the purpose of electing a three members of the Teague Board of Aldermen for a term of two years; and

WHEREAS, a Canvass of the General Election including the returns was conducted on May 13, 2019; and

WHEREAS, it was found that the persons herein named received the following votes for said term of office of Teague Board of Aldermen of the City of Teague.

Alderman Place II

Dennis Cox	received 105 total votes
Wendy Bain	received 35 total votes
Melvin Mims	received 102 total votes

Alderman Place IV

Jamie L. West	received 76 total votes
Chris Nickleberry Sr.	received 311 total votes

Alderman Place V

Ryan Mathison	received 264 total votes
Lois Ann Mims	received 127 total votes

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE CITY OF TEAGUE;

SECTION 1. The finds set forth above are incorporated into the body of this Resolution as if fully set forth herein.

SECTION 2. Rhonda Jones is hereby declared to be elected as Alderman Place II.

SECTION 3. Chris Nickleberry Sr. is hereby declared to be elected as Alderman Place IV.

SECTION 4. Ryan Mathison is hereby declared to be elected as Alderman Place V.


SECTION 5. The City of Teague hereby finds and determines as result of the Canvass held on May 13, 2019 that combined Election Day and Early Vote totals of **394** votes were cast in the General Election , consisting of **252** Early Votes cast and **142** Election Day votes cast as indicated by the Poll list for the General Election held on May 4, 2019.

SECTION 6. It is hereby declared the City of Teague approves and accepts the results of the General Election for the Alderman Place II, Alderman Place IV, and Alderman Place V as set forth in the Order attached hereto as Exhibit A, as determined by the majority vote of the qualified voters of the City of Teague.


SECTION 7. This Resolution will become effective immediately upon its passage by the Teague Board of Aldermen.
