## FEATHERS IN THE WIND

If any of you subscribe to "People" magazine (or wait in line at the grocery store) you might want be taken aback by the back cover. It's black and has the names of places (educational) crowded together. I highly recommend you seek out this magazine and look at the back.

In the past I have been told that I am "too liberal" (whatever that means). That I don't know what I'm talking about, that I don't understand "conservative mentality." I should just be quiet and let those "who know" take over.

## AMANA NEWS AND NOTES

Restore – Revive - Renew Moves Forward with Great Support

Amana Society Inc. Pledges Help

The Amana Church is raising money to repair and improve two historic buildings it owns; the Amana Church meetinghouse in Amana and the Kinderschule in Middle Amana behind the Middle Amana Church.

Sequel Architecture of Des Moines was hired to assess the structures and evaluate what is required to repair the buildings. The list of work required is long. The Amana Church Board of Trustees has elected to do this work in two phases, Elly Hoehnle, Amana Church administrator reported.

The estimated cost of these repairs and improvements is over \$400,000 The bulk of the work will be accomplished in Phase 1 of the project. The Phase 1 project cost estimate is \$364,387. This entails: constructing handicapped accessibility ramps, rebuilding fire escapes, continuing the work to restore windows, reconstructing the entry porches, residing the east and west sides of the church, installing more insulation, repairing fascia, soffits and other repairs at the Amana Church. At the Kinderschule the project includes installing heating/ cooling, restoring siding, replacing or repairing windows, repairing the entry porch, repairing the stone foundation, making electrical updates and more so that the building can be used as food storage and prep site by the Amana Community Food Pantry. This building is currently unused.

The need to find a new home for the Amana Community Food Pantry, currently housed in the basement of the Middle Amana Church, became vital with the increased need for food here. Over the past couple of years, the average number of families and individuals who rely on the Amana Food Pantry twice monthly has grown to 38 families. And co-chairs Annie Trumpold and Kristie Yoder see that need increasing.

"When we started we had just 14 or so families, now we are seeing on average 38 families and individuals and we believe that number will rise with the rising cost of food nowadays," Kristie Yoder told those who attended an ice cream social at the Amana Church Sunday.

The Amana Community Food Pantry is operated by the Amana Church with help from HACAP of Eastern Iowa. All the work is done by volunteers. Food is donated or purchased with cash donations. It is a confidential service that reaches out to people across Iowa County and here in the Colonies.

Likewise the Amana Church meetinghouse provides community services such as the Monday congregate meals program as well as being the largest house of worship for the church. As Jon Childers, fund drive co-chair said at the ice cream social, "These buildings while being historically significant are heart and soul. They are needed. We really use these buildings to carry out our mission to feed body and soul."

While the weekly congregate meals were discontinued during the COVID pandemic, volunteers hope to revive it soon. The Amana Church provides post funeral luncheons at the Amana Church and it's the home of the weekly Amana Sunday School, the summer vacation Bible camp, the youth group and the site of Bible studies. Plus it is available for community activities such as the Maipole dance rehearsals, family events and Boy Scout events.

The Amana Church has been working to maintain and improve the building. "Our volunteers have done so much. They have all worked incredibly hard," Hoehnle said.

Of course some work cannot be done as a volunteer project. In the past five years the church has replaced the roof, replaced the entire HVAC

system and made interior structural upgrades. "Now we need to get the exterior in shape, so the meetinghouse will be fully accessible and ready for the future," Hoehle added.

At the ice cream social on Sunday about 85 people attended to enjoy ice cream sundaes and hear about Restore -Revive-Renew. Excellent news was shared.

The Amana Society, Inc. Board of Directors and staff have pledged to donate \$50,000 over two years to the Restore - Revive - Renew fund drive to improve the buildings. This is the largest single donation from a private corporation and a critical help to the fund drive, said Emilie Hoppe, co-chair with Childers. "The Amana Church is very grateful to the Amana Society Board of Directors, to its management and entire staff for this support. This is particularly helpful as we kick off the campaign to raise the dollars. Thank you ASI, for all that it does, seen and unseen, to help, to improve and to support our entire community."

Thus far the Restore-Revive-Renew campaign has raised over \$220,000 in grants, cash, pledges and in-kind donations. However, over \$140,000 is still needed to reach the goal and get the repair work done.

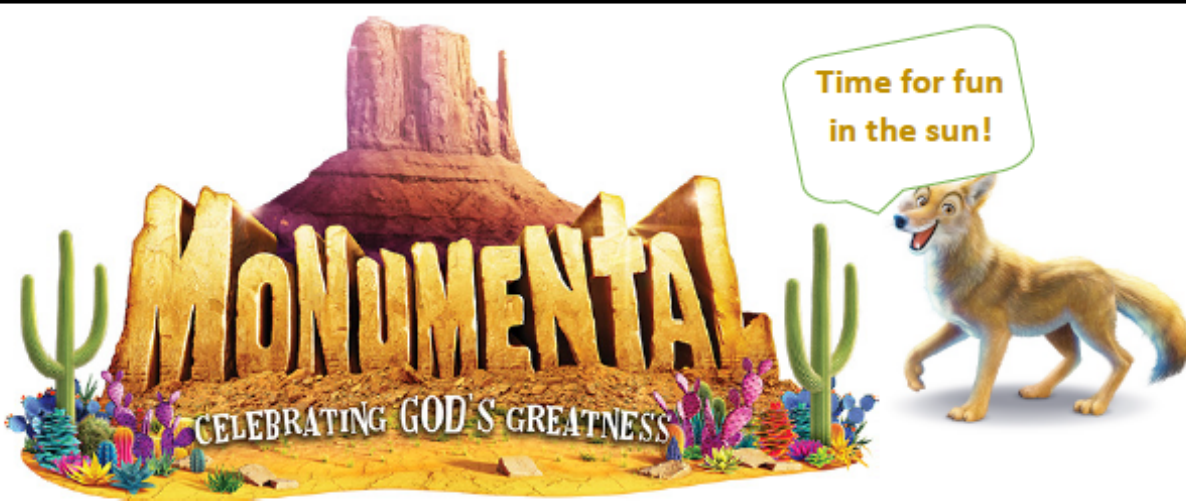
