PROGRAMS UNTIL APRIL 1, 2017 OR UNTIL THE MORITORIUM ENDED BY  
RESOLUTION BY THE JEFFERSON TOWNSHIP TRUSTEES.**

Trustee Back moved for the adoption of the following Resolution 16-118:

**WHEREAS**, The Jefferson Township Trustees in consultation with the Montgomery County Prosecutors Office are instituting a Moratorium on Accepting and Receiving New Applications for the Expand Your Lot Program, the Blairwood Program, and the Moratorium also applies to Granting permission for any new Application from all Non-Township Programs.

**WHEREAS**, The Jefferson Township Trustees are going to research, determine, and identify which current Applications are open and/or valid in both the Expand Your Lot Program and All Non-Township Programs, and will continue to process those existing Applications under the guidance of the Montgomery County Prosecutors Office.

**WHEREAS**, The Jefferson Township Trustees will be reviewing all Guidelines and Procedures that may exist with each Program to determine if changes need to be made to each Program before the Moratorium is completed.

**WHEREAS**, This Moratorium will remain Active, until the Board of Trustees Adopt a Resolution in a Public Meeting to End the Action.


