Treasurer Report

- New format for statement of activities report, including columns for budget vs actual for month and year to date (YTD). Expenses are in-line with anticipated expenditures. Electrical bill for February was twice as much as normal. Could anyone be using the power at the front wall? Board will be monitoring, when we can.
- To date, 63 out of 66 homeowners have paid the 2022 Dues.
- Some delinquent dues were collected so balance is higher than budget/anticipated.
- Remaining funds in checking account as of February 28 is \$19,898.15
- Reserve account balance as of February 28 is \$25,050.07.
- Another Board member (Steve) to help with insurance renewal.
- Reserve Account Susan asked is there a desired balance to keep in the reserve? There is a list of anticipated upcoming projects/capital projects the reserves are considered for as well as potential incident deductibles. Jenny to develop list for reserve fund minimum balance: Insurance \$2,000 deductible, cover checking account depletion etc.
- Estoppel fee increase was good but still much lower than the current market for similar valued homes. Could add \$100 to estoppel fee and still be within market. And this would help add funds to the community. **Board makes**

motion to increase estoppel fee to \$200 to move to market rates. Approved. Susan to verify \$200 is within market rate for estoppel fees and relay to Board.
