#### FY2023 Quarterly Interest - Fifth (Final) Interest Distribution

Treasurer Getty presented the fifth and final FY2023 interest distribution to the Trustees noting that the LTTO will be distributing an additional \$84K in interest to member districts for FY2023. That amount is approximately \$64K higher than the previous fiscal year.

#### FY2024 Quarterly Investment Report – September 30, 2023

Treasurer Getty presented the first quarter FY2024 investment report. In summary, the LTTO's total investment portfolio continues to outperform its benchmark (Bank of America Merrill

Lynch 1-10 Year Treasury & Agency Index) with 35.15% higher returns (LTTO: 1.066% vs. BOA ML 1-10 Index: 0.789%) in the first quarter of FY2024.

#### Cook County Property Tax Collection Delay - FY2024

Treasurer Getty informed the Trustees that the second installment of 2022 Cook County Property Tax bills are now available on the Cook County Treasurer's website and that the due date is December 1, 2023. The LTTO expects to begin receiving tax distributions in late November.
