## **ACREAGE ADULT FLAG FOOTBALL**

## AGREEMENT TO WAIVER OF CLAIMS AND LIABILITY RELEASE

In consideration of acceptance as a Participant in the Acreage Adult Flag Football Program, (hereafter the Program), the undersigned Participant (hereafter Participant) agree to the following Waiver of Claims and Liability Release (hereafter the Waiver and Release), which will cover events occurring from the time the Participant commences his participation in the Program until the Termination of his participation therein

## WAIVER OF CLAIMS AND LIABILITY RELEASE

It is the intent of the undersigned participant to release the Acreage Athletic League Inc., Indian Trail Improvement District and its employee's agents and volunteers from any claim or liability to the fullest extent possible under the law, and to advance that the intent the undersigned herby agrees as follows:

- 1. WE UNDERSTAND AND HEREBY ACKNOWLEDGE THAT THE GAME OF ADULT CO-ED FLAG FOOTBALL AND THE INHERENT RISK OF SERIOUS BODILY INJURY AND OUR WAIVER AND RENUNCIATION OF CLAIMS IN THIS AGREEMENT EXPRESSLY APPLY TO ANY BODILY INJURY, DAMAGE OR ACCIDENT THAT THE PARTICIPANT OR OTHERS RESULTING FROM THE PARTICIPANT'S PARTICIPATION IN THE GAME OF ADULT CO-ED SOFTBALL IN CONNECTION WITH THE PROGRAM.
- 2. We the undersigned as a Participant in the Program, hereby waive and renounce any claims against the Acreage Athletic League, Inc., Indian Trail Improvement District, Palm Beach County, and their volunteers employees, sponsors, agents, and affiliates, or any other person participating in the Program, Including without limitation, for any injury to the Participant or others, loss damage, sickness, accident delay or expenses of any kind whatsoever resulting from the Participants participation in the Program.
- 3. We also agree to hold harmless the Acreage Athletic League, Inc., Indian Trail Improvement District, Palm Beach County, its employee's agents and volunteers from any and all claims arising out of the equipment or uniform supplied to Participant for the use in the Program or the equipment or other material used by the Program staff in implementing the Program.
- 4. We understand and acknowledge that the Acreage Athletic League, Inc., Indian Trail Improvement District, Palm Beach County, its employees and volunteers do not guarantee the security or safety of Program sites, or the areas adjacent to and surrounding Program sites or of any area Participants may traverse on their way to or from program sites. We release the Acreage Athletic League, Inc., Indian Trail Improvement District, Palm Beach County, its agents and volunteer from any and all claims arising out of accidents or events caused by a Participant to third parties not associated with the Program which Incidents could occur of Program sites, in areas adjacent to or surrounding Program sites or in areas traversed by participants traveling to our program sites. We further release the Acreage Athletic League Inc., Indian Trail Improvement

District, Palm Beach County, its employees or volunteers from liability for any damage or injury that may occur as a result of the surface or condition of the Program site itself (e.g. the playing field), or the condition of facilities or equipment used at the site.

- 5. We recognize that the Participant must obey rules of the league and any other program staff and we have instructed the Participants to obey said Program. We understand and acknowledge the Program staff and the Acreage Athletic League, Inc., Indian Trail Improvement District Palm Beach County, reserve the right to terminate the participation in the program of any Participant whose conduct may be considered by the Acreage Athletic League, Inc., Indian Trail Improvement District Palm Beach County, in its sole discretion, to be detrimental to or incompatible with the interests and security of the Program or the Acreage Athletic League, Inc. Indian Trails Improvement District, the Indian Trail Water Control District or Palm Beach County. In the event of any such action by the Acreage Athletic League, Inc., Indian Trail Improvement District Palm Beach County, we understand and acknowledge that we will have no right to any compensation or damages from the Acreage Athletic League, Inc., Indian Trail Improvement District, Palm Beach County, its agents or volunteer.
- **6.** We further understand that should any medical service be provided or made available to the Participant in connection with his participation in the Program, the provision or availability of which the Acreage Athletic League, Inc., Indian Trail Improvement District, Palm Beach County, does not sponsor or guarantee, the Acreage Athletic League, Inc., Indian Trail Improvement District, Palm Beach County, does not warrant or make any representation concerning the adequacy or continuation of such medical service nor can the Acreage Athletic League, Inc., Indian Trail Improvement District, Palm Beach County, be deemed responsible or held liable for any claims arising out of the provision of such medical services of the failure to provide or to continue to provide such medical services. We also understand that the Acreage Athletic League, Inc., Indian Trail Improvement District, Palm Beach County, cannot be held liable for any other services provided in connection with the Program, including without limitation any coaching, counseling, transportation or security services.
- **7.** If any portion of the Waiver and Release is invalid or unenforceable by a final judgment court of any court of competent jurisdiction, we hereby agree that such determination shall not affect the balance of this Waiver and Release, but this Waiver and Release shall remain in force and effect, as such invalid portion shall be deemed severable.
- **8**. In other words to keep it simple John, Doug , Kim, A.A.L. & I.T.I.D are in no way liable or responsible if you get hurt. Reminder there is absolutely no Alcohol at Community Park. This is a fun league, don't take it so seriously, have fun & play safe.
