I understand that I am voluntarily participating in an event (such as Calf, Team & Breakaway Roping, Steer Stopping, or others) sponsored, promoted and/or organized by the Michigan Ropers' Assoc. I understand that horse-related activities including roping, horseback riding, and riding or working near cattle are rugged and dangerous activities which carry a risk of bodily and other injuries. Injuries could include loss of life and serious bodily harm. Risks could include, for example, equipment failure, collisions, kicks and getting trampled, unpredictable reactions by horses and cattle, and several others. I represent that I am physically able to perform activities at this event. **I UNDERSTAND THESE AND OTHER RISKS AND DANGERS ASSOCIATED WITH ROPING AND EQUINE EVENTS AND ACTIVITIES, AND I VOLUNTARILY AGREE TO ASSUME THEM.**
