**Ribbons:** Each dog who successfully passes the test will receive a qualifying ribbon.

**Dog Eligibility:** Dogs who are **at least 1 year of age** are eligible to take the ATT and must either be AKC or FSS registered or listed with Canine Partners or have a Purebred Alternative Listing number. Dogs that are spayed or neutered may participate.

Dogs that urinate or defecate during testing are Disqualified.

Dogs with disabilities such as those that are blind, deaf, or have three legs are eligible to enter provided in the opinion of the evaluator they display no signs of physical discomfort and can safely complete the test. However, if a dog has multiple disabilities such that, it is unable to complete whole categories of the test (i.e. - hearing auditory stimuli and seeing visual stimuli), the dog would not earn the ATT title."

Bitches in season ARE allowed to enter and will run last for both morning and afternoon testing. Failure to disclose your bitch is in season to an evaluator is a Disqualification. Bitch panties can be worn but no jackets, thunder shirts or vests.

### ENTRY METHOD: FIRST RECEIVED DAY OF SHOW

**ENTRIES CLOSE ON: Day of Show for AM Test at 12:00PM or when full and PM Test at 4:00PM or until full.**

Please make checks payable to the **Tacoma Kennel Club**. The trial secretary will add a \$35.00 collection fee to the amount of each returned check.

**Entry Limits/Waiting List/Multiple Dogs:** There will be an entry limit of 20 dogs per test with a 10 dog waiting list.

**Collars, Leashes and Harnesses.** Dogs may wear slip collars that are on a dead ring, buckle collars, martingales and body harnesses in the ATT. They may not wear prong collars, head collars, e-collars, or harnesses that restrict the movement of the dog. Leashes should be 4 ft or 6 ft long and should be made of fabric or leather.

When exercising your dog(s) please clean up after them! Dispose of 'poop' bags in the trash containers provided outside.

**It is expressly understood** that all owners/agents/exhibitors are solely responsible for the behavior of their dogs and/or children. Any person(s) whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such cases, no refund of any fees paid will be made. Tacoma Kennel Club and their agents, employees, etc. will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property, and further assume no responsibility for injury to children. Tacoma Kennel Club reserves the right to decline entries for cause and may remove any dog because of aggression. No one shall have any recourse or claim against the Tacoma Kennel Club, Bethel Learning Center or any official thereof.

**Entry fees:** Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by a Veterinarian or Judge, or barred from competition by action of the Trial Committee.

**Errors on Entries:** Owners are responsible for the accuracy of the information required on the entry form. **The Trial Secretary, in writing or via e-mail, must receive changes, additions, or corrections to an entry, entry substitutions or cancellations, prior to the closing date of the trial.**

**Judging:** Neither the Trial Secretary nor any other individual is obligated to call or notify exhibitors when they are due in the ring for judging. Judges are not required to wait for any exhibitor. Dogs need be present only for scheduled judging and will be released if not needed for further judging.
