Financial Overview

- Revenue for the Parking Authority through June 30, 2019 was \$13,646 higher than 2018. Administrative expenses were \$9,672 lower than 2018 and Operational expenses were \$53,780 lower than in 2018. Year to date net revenue for 2019 is \$128,773 which is \$78,759 higher than in 2018.
- Revenue for the Park and Ride through June 30, 2019 was \$1,962 higher than 2018 with expenses being lower by \$14,464. Year to date net revenue for the Park and Ride is \$38,262 which is \$16, 426 higher than it was in 2018.
- The combined full year projection for the "Change in Net Position" is expected to be \$129,836 an improvement of \$77,580 from 2018.
