Appraisers National Association (ANA) actively seeks to retain the membership of professionals who have an interest in the issues related to the appraisal of personal property, and pride themselves on meeting the highest standards of professional appraisal practice.

There are currently Four (4) Levels of membership:

## <u>Certified Accredited Appraiser (CAA)</u> Sanctioned by ANA to Appraise.

- 1. CAA Members must have successfully completed the educational requirements for certification from a recognized educational institution, appraisal society, or equivalent professional training and experience recognized by ANA.
- 2. Each CAA Member Must be up to date with current USPAP edition. And every appraisal assignment must comply with USPAP by meeting the current guidelines established by USPAP.
- 3. Each CAA Member is required to complete 30 Hours of Continuing Education Annually.
- 4. Every CAA must comply with the ANA code of ethics.\*

#### Student Member (SM) Not Sanctioned by ANA to Appraise.

Individuals who are currently enrolled in a course of instruction from a recognized educational institution. Must provide documentation showing current enrollment.

Student Associates must comply with the ANA Code of Ethics.\*

#### Associate Member (AM) Not Sanctioned by ANA to Appraise.

Individuals or businesses whose main interest is in the field of personal property i.e. Estate Sellers, Dealers, Auctioneers, Estate Buyers, Brokers or other Related Professions. Associate Members must comply with the ANA Code of Ethics.\*

#### Expert Consultant (EC) Not Sanctioned by ANA to Appraise.

Individuals who demonstrate a high level of expertise in a singular narrow field of specialization. For example: Specialty Scholars, Curators, Conservators, Linguists, Collectors, Authors, Historians, Attorneys, Insurance Specialists etc.

Expert Consultants must comply with ANA Code of Ethics.\*

#### For Returning CAA Members we request the following:

- 1) A copy of your current USPAP Certificate if available. (if you have not already sent it in)
- 2) Log of your Thirty (30) Continuing Education Hours including Receipts, Certificates Etc. (May be photocopied onto one sheet of paper to save resources.)
- 3) COMPLETED Membership Renewal Form.

Note: Any educational, professional and/or USPAP information provided will be verified.
