The Rebirth Of Imperial Russia

There will not be a specific lesson in history in this issue of the Intelligence Newsletter. This entire issue will be devoted to current affairs that are of profound importance to us if we are ever to understand what we must do to regain our Christian heritage. These current affairs will reflect incidents and trends that prove to us that Christianity is no longer the guiding principles on which this nation governs itself. To that end the entire issue is a lesson in history.

For the past nearly two thousand years there has been a conflict that has embroiled not only the two major participants but the entire world. When the early Christians began telling everyone that the Saviour had already come and that we must rid ourselves of Phariseism (later Talmudism), the Jews began their unending contest to regain the birthright. They shouted to anyone who would listen that *"These that have turned the world upside down are come hither also."* ([Acts 17:6](#))

Jesus told them in a parable and then straight-out, *"Therefore say I unto you, The kingdom of God shall be taken from you, and given to a nation bringing forth the fruits thereof."* ([Mat. 21:43](#)) If anyone might question the final outcome of this battle of two milleniums, the next verse in Matthew should suffice. *"And whosoever shall fall on this stone shall be broken: but on whomsoever it shall fall, it will grind him to powder."* ([Mat. 21:44](#))

The battle began and it has never let up. At first, the antichrists were on top and the Bible tells only a very small number of things they did. One day, God willing, we will tell more of the sordid story. But Christianity continued to grow and influence the entire world in morals and customs. The antichrists penetrated the early Universal Church with very clever heresies which came from the minds of the masters of intrigue. The Universal Church decayed into the Popish Church because of it.

Martin Luther tried to reform it but the Protestant Reformation was penetrated even more deeply than the earlier Universal Church. Christians would fight back with all the means at their disposal, with only limited effect. Finally, the inquisitions were ordered. This had only a limited, short term effect. The mistake was made to allow the antichrists to be baptised and become "Christians". Thus, now they could continue to destroy Christianity from within. Many took positions of leadership within the church. Contrary to what is taught in the modern seminaries and contrary to the current array of laws designed to show the antichrists as the winner, the fight still continues.

Proceeding now to more modern times, the question is often raised to determine the role that greater Russia has played in this battle. It has been by sheer predestination that the people of Eastern Europe and Russia have brought the battle to the struggle we see today. The remainder of this issue is to show how that battle continues and it should shed some new light on current affairs. The examples given here are by no means the most

important that have occurred in recent years; however, they are current and perhaps, through that, we can better understand the conspiracy that still exists.

By now all of us must be wondering what all of the activity in Russia portends for the future. We here at Christian Crusade for Truth are no exception. We are reeling because of the multitude of analyses that are being published.

However, there are some observations that we can make that should give some insight as to how current affairs fit together in the continuation of that great battle. Some of these observations are a little humorous (if it weren't so deadly serious) and are somewhat analogous to the "rats leaving the sinking ship!"



Moscow, Russia

By now, every person in the United States should (but doesn't) realize that the Bolshevik Revolution in 1917 was funded by Wall Street and the International Bankers. The conduct of the revolution was carried out by a predominantly Jewish group of approximately 3000 well trained revolutionaries. Communism, the 1905 and 1917 Bolshevik Revolutions and the U.S.S.R. come from the minds of Talmudic Jewry. The Sept. 10th, 1920 issue of the *American Hebrew*, says it all. "The Bolshevist revolution in Russia was the work of Jewish brains, of Jewish dissatisfaction, of Jewish planning, whose goal is to create a new order in the world. What was performed in so excellent a way in Russia, thanks to Jewish brains, and because of Jewish dissatisfaction and by Jewish planning, shall also, through the same Jewish mental and physical forces,

become a reality all over the world."

It is recognized that the Communist dream in Russia backfired on the perpetrators. Stalin's purge eliminated many of the original leaders, along with their followers. However, the entire government of the U.S.S.R. was manipulated from within by the same Talmudic forces. The military was required to have a political commissar in each division who was Jewish. The KGB was staffed almost entirely with Jewish agents.

However, as the world, and particularly the people of Russia, saw the utter futility of the Talmudic Communist dream, the Jews of the world started to distance themselves from the ideals of the Soviet Union and from world Communism, at least on the surface.


We are now witnessing what appears to be the dissolution of the Communist structure, at least in Russia proper. We are observing all sorts of "slight-of-hand" tricks to remove Talmudic Jewry and Zionism from Communism. For example, when the recent coup was attempted in the Soviet Union with the purpose of returning the country to Communist rule, the controlled news media here in the United States blatantly lied as to who the perpetrators were. Instead of informing the public that the leaders of the coup were hard-line Communist leaders (which all of us know is defined as extreme left-wing), they repeatedly told us that they were radical conservatives of the extreme right-wing!

This sort of intellectual dishonesty has been growing for some time now. It has already been shown that Talmudic Jewry is very Socialistic in nature. The United States Congress conducted many investigations into Communistic influence in our country in the 1940's, 1950's and early 1960's. Any Congressman, or anyone for that matter, who spoke out on this obvious connection was immediately labeled as anti-Semitic. Men like Joseph McCarthy were driven to their graves with vitriolic epithets such as "McCarthyism."

As the Jewish love affair with Communism waned in the late 1960's and 1970's, their political affiliations also changed. For many years, the description of "right-wing" and "left-wing" used the ordinary circle in its definition. The centrist position was at the top of the circle and as a person became more "right-wing" he would move clockwise around the circle until he reached the bottom of the circle, at which time he became known as a Nazi or a National Socialist. If he moved counter-clockwise around the circle he became more "left-wing" until he reached the bottom of the circle and he would then become known as a Communist. Both the extreme right-wing and the extreme left-wing joined at the bottom of the circle. At least, this was the case by definition.

A mass exodus was taking place all over the world from Communism by Talmudic Jewry. Many of them left the "left-wing" or Socialist-Communist persuasion and became "neo-conservatives" but they did it with a particular flair. They retained many of their Socialist views but joined the so-called Republican party and brought into it the totalitarianism of the old Federalists.

Consequently, greatly because of them, the old circle description of "left" and "right" had to be replaced. It was replaced in political science circles with what is called the Nolan Chart. The definitions are changed. A graph is formed with the ordinate or y axis reflecting social freedoms and is measured from 0 to 100%. This is called "left-wing." The abscissa or x axis represents the economic freedoms and is likewise measured from 0 to 100%. This is called "right-wing."

When one studies this chart, it becomes obvious what has been done to us. Those who not many years ago were classified as Communists, can now fight for "social freedoms" such as homosexuality, pre-marital sex, sex education (Kindergarten through 12th. grade), women's liberation, liberalization of drug use, total pluralism, freedom from Christian principles, etc. At the same time, they can have the economic freedoms of the free enterprise system guaranteed by the Christian principles. The only problem is that they don't heed the limitations of economic freedoms placed on them by the same Christian principles.

The first response to this dichotomy is that they have given up Communism. No, they haven't given up Communism. They have gained the social freedoms that they couldn't have even in the Soviet Union and at

the same time have unlimited economic freedoms, far exceeding the limits of Christian principles.

Returning to the Russian scene. During the recent coup attempt, three young men were killed in the heat of the confrontation. One of the young men was Jewish and the other two were non-Jewish. The Russian people considered them all to be martyrs and a much publicized public service was held for them. The visibility of Russian Orthodox priests was very evident. This means that the Christian Church is again being recognized. In fact, it is

very obvious that the Christian Church is in the forefront of the massive changes being seen in Russia.

At the public service a Rabbi was also allowed to conduct his service for the young Jewish man who was killed. It is significant that this young Jewish man had recently been given his immigration visa to go to Israel.

What has been the response to these actions within the leadership of the American Jewish community? This can best be described by excerpting from an article found in the *Religious News Service* for August 30, 1991. The article was written by Rabbi James Rudin who is the director of the American Jewish Committee's interreligious affairs and is a founder of the National Interreligious Task Force on Soviet Jewry.

After citing the incident described above he says, "For nearly 75 years the Soviet Union has officially been an atheistic state, and for many of those years, the Communist rulers carried out an aggressive campaign that prohibited parents from giving spiritual instruction to their children, closed seminaries, persecuted believers and suppressed the publication and distribution of prayer books, Bibles and other articles of religious expression. Soviet Jews, Ukrainian Roman Catholics and Pentecostal Christians were special targets of the Communist authorities."

"The Soviet regime often sponsored acts of anti-Semitism, and Jewish activists like Natan Scharansky were falsely imprisoned for many years. Many Jews who sought visas to leave the Soviet Union were kept waiting for years, and a new word, 'refusnik,' entered our vocabulary."

"For over 20 years, the struggle to bring freedom to Soviet Jewry has been one of the world's major human rights efforts. In this country Jews and Christians worked together in a remarkable interreligious effort that helped keep the Soviet Jewry movement alive, even in its darkest days."

"At the same time that Jews were leaving in record numbers, the old Soviet anti-religion policy was weakened, and then finally abandoned. Religious faith, the first target of every totalitarian regime, has emerged with renewed vigor and credibility. Although the recent public funeral in Moscow was a sad occasion, it was also a symbolic confirmation of the failure of the atheistic Soviet state."

"But with this sense of confirmation must also come a sense of caution. During Tsarist rule in Russia, religious faith, especially that of the Russian Orthodox Church, was often a source of extreme nationalism, xenophobia and anti-Semitism. The intense entanglement of the church and the regime usually resulted in political corruption and moral decadence. In the popular mind, this linkage is personified by Gregor Rasputin, an Orthodox priest who wielded enormous political power during the last days of the Romanov dynasty. Indeed, the very name, Rasputin, has come to mean the evil influence of religion in the affairs of state."

"Today we rejoice that religion in the Soviet Union has been freed from the dungeon and has entered into the light of freedom. However, we must remain vigilant. With credibility comes responsibility."

"Just as we pressed our campaign to bring freedom to Jews and Christians who suffered under Communist rule, we must now press with equal commitment our campaign to guarantee that religion within the U.S.S.R. does not now become an instrument for new prejudice and repression."

"Many positive things have happened in the world of religion since 1917. Hopefully, the hard won principles of religious liberty, individual conscience, minority rights and religious pluralism will also become an integral part of the republics of the U.S.S.R. The symbolism and the rabbi and the patriarch drawn together by tragedy was both startling and encouraging." End of quotes from Rabbi James Rudin's article.

This is a typical example of intellectual dishonesty. Let us go over his points one by one. "For nearly 75 years the Soviet Union has officially been an atheistic state...closing seminaries, persecuted believers...suppressed...Soviet Jews, Ukrainian Roman Catholics and Pentecostal Christians..."

This is now 1991 and 75 years ago was 1916. That was the very time that his own people were creating the revolution and were assisted financially by people of like religious persuasion in the United States. Their intentions from the outset were that Russia would be atheistic. He indicates that Jews, Roman Catholics, and Pentecostal Christians were the targets. No mention is made of the Russian Orthodox Church. This is significant. The Church Times in London on April 13, 1923 said, "Already twenty-eight bishops and twelve hundred priests of the Russian Holy Orthodox Church have been sacrificed to the Bolshevik hatred of the Christian Faith."

"The regime...sponsored...anti-Semitism, and Jewish activists like Natan Scharansky were falsely imprisoned for many years... 'refusnik' entered our vocabulary." Our history books don't read quite that way. George Bernard Shaw, quoted in *The Jewish Guardian* of London on August 7, 1931 said, "I have seen the statement which Joseph Stalin gave recently to the Jewish Telegraphic Agency on anti-Semitism and in which the Soviet leader said that under the Soviet laws militant anti-Semitism is punishable by death." Also, Kurt Blumenfeld stated in the *Jewish Frontier* (New York), January 1942, "Up to 50% of the Jews in the Soviet Union are engaged as officials, clerks and in the intellectual professions. In the totalitarian Communist system the Jew, instead of being engaged in trade and business, has been the official, the employee of the State." Rabbi Rudin makes no mention that the Jews officiated in the Soviet regime.

"During Tsarist rule in Russia...the Russian Orthodox Church was often a source of extreme nationalism, xenophobia and anti-Semitism... resulted in political corruption and moral decadence...this linkage is personified by Gregor Rasputin, an Orthodox priest who wielded enormous political power during the last days of the Romanov dynasty...Rasputin, has come to mean the evil influence of religion in the affairs of state."

Grigory Yefimovich Rasputin was born in 1872 and died Dec. 30, 1916 in St. Petersburg. He was a Siberian peasant and mystic whose ability to improve the condition of Alexis Nikolayevich, the hemophiliac heir to the Russian throne, made him a powerful favorite in the court of Emperor Nicholas II and Empress Alexandra. After a two-year study at Mt. Athos in Greece, he returned to Russia and soon became widely known for his healing arts. He was in no way a Russian Orthodox Priest. The high society of St. Petersburg warmly received the filthy, unkept peasant with brilliant eyes and extraordinary healing talents. He was recommended by high church officials to the imperial family in 1905 because of his ability to heal illness. When he demonstrated an ability to ease the suffering of the young Alexis, he was welcomed into the family circle as a close and trusted friend, and Alexandra came to revere him as a holy man sent by God to save her son, the Romanov dynasty, and the Russian autocracy.

When Emperor Nicholas II went off to take command of the army during World War I, the Empress Alexandra acquired greater control of the domestic affairs. Rasputin moved in and replaced capable officials with unscrupulous men who made decisions adverse to the

best interests of the Christian Tzars and to Russia. It is possible that these men were but forerunners of the 1917 revolution.

The friends of the aristocracy attempted to kill him by poison which didn't work and then by shooting him twice which also didn't work. Finally they succeeded by drowning him in the Neva River by throwing him in a hole in the ice covered river. It is true that Rasputin was a very base and coarse individual with unclean and immoral habits. But he was in no way a Russian Orthodox Priest and he certainly did not represent the "intense entanglement of the church and the regime (which) usually resulted in political corruption and moral decadence."

Rabbi Rudin stated, "Just as we pressed our campaign to bring freedom to Jews and Christians who suffered under Communist rule, we must now press with equal commitment our campaign to guarantee that religion within the U.S.S.R. does not now become an instrument for new prejudice and repression. Many positive things have happened in the world of religion since 1917..."

It is certainly true that many things have happened in the world of religion since 1917. But they have been anything but positive. Since 1917, Christianity has been changed into Judeo- Christianity. The term was never heard of 75 years ago. Judeo- Christianity with its pluralism is now ordaining homosexuals and women. The greatest debates now going on in official church councils relate to the values of pre-marital sex and extra- marital sexual relationships. It is common knowledge that the so- called Christian book publishers are owned by non-Christians. The seminaries use Jewish Rabbis as teachers of the Bible. There are very few individual Christian Churches where the evils of our society and government are addressed. The people are staying home, just like they did in Russia, and are receiving their guidance from those government approved preachers on TV.

Yes, it appears that Russia is changing and perhaps going back to the system of the Christian Tzars. Certainly we haven't heard the last of Communism. There are hundreds upon hundreds of millions of Communists still active in the world. It is highly possible that the extremists within the Communist apparatus will still stage a successful coup, or even an international conflict.

But it appears, just appears, that white, Christian Russia is returning to Christianity and old fashioned Imperial Tzarism. It also appears that they are certainly willing, even hopeful, that the Plutocratic West will give them financial assistance just like was given to Germany and Japan after World War II. And we should expect, just like Germany and Japan, that they will move out on their own with renewed vigor.

We have pointed out in past issues of The Intelligence Newsletter that we can expect Germany, Russia (white Russia), Japan, the Moslem people, and the Vatican to enter into an alliance in the future. All of these are classically anti- Zionist. In spite of what is currently happening in the Vatican with Ecumenicism and brotherhood with Israel, the old, old time Catholics know what is meant by "antichrist." This is evidenced in books such as Maurice Pinay's *The Plot Against the Church*.

Shouldn't we be learning something from the fact that we, as a country, are becoming more totalitarian and Communistic as the Talmudic Jew moves to the United States and Russia becomes less Communistic and totalitarian as they leave? As a point, we read that the United States now has over twice the number of inmates in prison as does Russia. We are building prisons faster than we are schools. A very large share of all inmates are in prison because of laws promulgated since George Bush became president. The incidence of political prisoners has exploded.

When did this immigration start? We have a tape titled The Immigration Scam which is available for the asking. It gives the history of the immigration from Russia since the late 1800's and what happened to them.

In a *New York Times* article, dated August 31, 1991, Mr. R. Bernstein postulated that the demise of Marxism/Leninism, Communism, and Bolshevism in the Soviet Union has now created new issues which will prevent the dream of a world-wide Zionist state.

For reasons not heretofore fully understood, the West, and in particular the United States, has for many years sought to keep the Soviet Union intact as one large empire. At the peak of the Polish uprising in 1863, the official policy of the United States supported the unity of Russia and the inclusion of Poland as part of Russia. When the Polish sailor deserted from the Russian cruiser several years ago, our government retained this policy when they forced his return to the ship and he was hanged from the ship's mast.

The United States government has worked desperately to keep the Russian empire intact during this current crisis. If the Soviet Union breaks up into many smaller, ethnically oriented nations, the power base for "Greater Zionism" has been lost. The ancient empire of Kazaria, the origin of the Ashkenazi Jews, has been assimilated through the years into all of the Eastern bloc countries, which is the "Soviet Union." As the power base of the Soviet Union disintegrates, so goes the power base of the Ashkenazis. We now can understand the concern of Rabbi Rudin in his article, as well as that of the *New York Times* article of R. Bernstein.

U.S. Policy Toward POW/MIAs

As we read the following article, we should relate what we learn to the preceding article. They go together.

Finally, after so many years of hard work, sweat and tears the many, many people who have worked toward forcing the government to give an accounting for all of the Prisoners Of War (POW) and those Missing In Action (MIA) are beginning to see results. We all know of actual sightings of American prisoners in Vietnam, Korea and in Russia. One man in particular, John Noble, escaped from the Russian slave labor camps and reported many other Americans there, some who have been there for a long, long time.

We knew, with total disdain and disgust, that the official policy of the government of the United States, supposedly the land of the free and the home of the brave, was that such prisoners were all dead and therefore nothing could be done. Even in recent weeks and months men like the National Security Advisor proclaimed the same official position. This was the official propaganda distributed to the American public by the controlled news media, even while they knew full well that the Senate Committee on Foreign Relations was investigating and preparing a report on the subject of these prisoners of war and those missing in action.

But we must give credit and applaud Senator Jesse Helms of North Carolina. He put together a small investigative team and under his direction prepared a document titled An Examination of U.S. Policy Toward POW/MIAs. It is dated May 23, 1991.

Senator Helm's forwarding letter is copied in its entirety. This is done because of the importance of the matter. It is but another example of a government gone awry. "Dear Colleague: On October 29, I released an interim report prepared by the Minority Staff of the Senate Committee on Foreign Relations based upon a on-going investigation of the

POW/MIA issue. That investigation has continued. It was not, and was never intended to be, a search for specific POW/MIAs."

"Such an effort would be beyond the scope of the resources available to the Minority. Rather it was an attempt to ascertain whether the agencies of the U.S. government responsible for POW/MIAs were doing the job they were supposed to do--that is, to find any POW/MIAs who might still be alive."

"The interim conclusions are very disturbing. After examining hundreds of documents relating to the raw intelligence, and interviewing many families and friends of POW/MIAs, the Minority Staff concluded that, despite public pronouncements to the contrary, the real, internal policy of the U.S. government was to act upon the presumption that all MIAs were dead."

"As a result, the Minority staff found, any evidence that suggested an MIA might be alive was uniformly and arbitrarily rejected, and all efforts were directed towards finding and identifying remains of dead personnel, even though the U.S. government's techniques of identification were inadequate and deeply flawed."

"These conclusions, although welcomed by the families and friends of POW/MIAs who had direct experience with the U.S. government's POW establishment, were hotly rejected by that establishment."

"However, on February 12 the Chief of the Special Office for Prisoners of War and Missing in Action (POW/MIA) resigned. Colonel Millard A. Peck, a man who had accepted the position with high motives and a sense of deep dedication, felt that he could no longer fulfill the demands of duty, honor, and integrity under the policies which he was asked to implement."

"In a detailed and forthright letter, which did not become public until May, Colonel Peck confirmed that a `cover-up' has been in progress. He spoke of a `mindset to debunk.' He said that there was no effort to pursue `live sightings.' He stated that `any soldier left in Vietnam, even inadvertently, was, in fact, abandoned years ago.' Lastly, he criticized the U.S. government's treatment of the families and friends of the POW/MIAs."

"The entire text of Colonel Peck's letter appears in the current report. The fact that Colonel Peck's conclusions were so similar to the conclusions of the Minority Staff is a matter of regret, rather than a vindication. I had hoped that the Minority Staff investigators would be able to alter their preliminary findings, because the implications of a deliberate effort by the U.S. government to deceive the American people is a matter that all of us would prefer to believe unthinkable."

"However, as the Minority Staff pursued its investigations, it became clear that the U.S. experience with the Vietnam POW/MIAs is not unique in history. Echoes of similar experiences in dealing with other, and earlier Communist regimes on the subject of POW/MIAs came up with increasing frequency. Although substantial portions of the current report had already been prepared, I directed the staff to track down the historical precedents. I felt that these precedents were absolutely necessary to an understanding of the present problems, even though it necessarily delayed the release of the report."

"Of course, this fundamental historical research required a massive undertaking to find the original documents, most of them formerly classified, in the National Archives and in the issuing agencies. Accordingly, readers will find in this report something which has never before been attempted: An historical analysis of the fate of U.S. POW/MIAs in the hands of

the Bolshevik regime after World War I, the Soviet regime after World War II, the North Korean regime after the Korean War, and the Vietnamese regime after the Vietnam War."

"In each case, the same dismaying scenario appears: On the Communist side, the regimes denied holding U.S. prisoners, contrary to many credible reports, while in fact they were holding the U.S. POW/MIAs as slave laborers and as reserve bargaining chips to get diplomatic recognition and financial assistance. On the U.S. side, our government downplayed or denied the reports of POW/MIAs, and failed to take adequate steps to prove or disprove the reports, while elements in our government pursued policies intended to make diplomatic recognition and financial support of the revolutionary regimes possible."

"I find this evidence convincing; doubters should examine the cables and classified memoranda cited in Part I which tell the full story. Part II examines anecdotal evidence which the Minority Staff has chosen to illustrate the massive problems with the U.S. government's handling of the POW/MIA issue--problems which were only suggested in the interim report."

"While investigation into the present problems continues, it is evident from the work already done by the Minority Staff that more time and more resources need to be devoted to the work. Senator Bob Smith (R-New Hampshire), a long-time stalwart in the ranks of those dedicated to the POW/MIA cause, has introduced S. Res. 82, to establish a Senate Select Committee on POW/MIA Affairs. S. Res. 82 has already attracted wide bipartisan support, and deserves the support of every Senator."

"This report has required many hundreds of hours of work, not only from the Minority Staff, but from many dedicated persons who shared their experiences and research with the Minority Staff. I would be especially remiss were I not to mention Dr. Harvey Andrews, Thomas Ashworth, John M.G. Brown, and Mark Sauter of CBS affiliate, KIRO-TV, Seattle, Washington. Needless to say, the conclusions are those of the Minority Staff, and not necessarily those of Messrs. Andrews, Ashworth, Brown, and Sauter. Sincerely, Jesse Helms." End of the forwarding letter for the Senate Committee report *An Examination of U.S. Policy Toward POW/MIAs*.

Duty, Honor, Country

An editorial in the *San Francisco Examiner* of Sept. 14, 1991 reads, "Somewhere along the border of Iraq and Saudi Arabia you will find a grisly monument to the gulf war. Arms and legs are left protruding from the sand where the Iraqi defensive lines dug in. During the first two days of the ground war, three brigades of the First Mechanized Division, safely

ensconced in tanks and armored vehicles, literally plowed through enemy trenches. Unknown thousands of soldiers were buried alive under tons of sand. Not one American soldier died in the attack. Not one Western journalist was aware of the slaughter. The truth only came out when returning troops told their tale to *New York's Newsday* last week."

"War is hell. That much has not changed. Images of the Western Front, the streets of Nagasaki and the napalm-scoured jungle of Vietnam are a reminder that, in the 20th century, hell has only sunk deeper and become even more fiery."

"But propaganda from the gulf managed to change the public face of war because it was such a one-sided battle. No need to show pictures of wounded American soldiers limping away from the front line if nobody on our side was dying. Instead we were treated to pictures of Patriot missiles shooting down Scuds and cockpit videos of bombers razing a building with laser-guided accuracy. War was Nintendo, without a bloody nose in sight."

"The Pentagon's tight controls on press coverage kept reporters-and the American public-away from the nasty stuff. By doing so, the pernicious notion that war isn't really that bad crept in. Last week's revelations are a shocking reminder of the fallacy of that idea and reinforce the principle that the media must be able to present war the way it is: brutal-and a last resort." End of article from the *San Francisco Examiner*.

Our first reaction to this story is disbelief. Our disbelief is that our soldiers would do such a thing. Yes, we would do such a thing, in this new age of "surgical" warfare, the "hi-tech" art of killing.

We naturally question how our soldiers could do such a thing and it is also natural to blame them. No, it isn't their burden to bear. It is our shame; "of the people, by the people and for the people." The soldier is a servant. He, for all practical purposes, is a slave with a master as long as he is in uniform. Duty, honor, country.

DUTY. Jesus said in [Luke 17](#), *"If you had faith the size of a grain of mustard-seed, you would say to this mulberry tree, Be uprooted and planted in the sea, and it would obey you. Which of you, with a servant out ploughing or shepherding, will say to him when he comes in from the field, Come at once and take your place at table? Will the man not rather say to him, Get something ready for my supper; gird yourself and wait on me till I eat and drink; then you can eat and drink yourself?"*

"Does he thank the servant for doing his bidding? Well, it is the same with you; when you have done all you are bidden, say, We are but servants; we have only done our duty." (Luke 17: 6-10 Moffat translation.) When Jesus gave that illustration, the average relationship between the master and servant was the lord and slave arrangement. This story in Luke describes duty and service and these are attributes of good soldiers.

HONOR is a word that has a very special meaning. It means high respect, esteem shown to, or received from, or felt in regard to another person. The Bible shows it to be the possession of a person, closely connected with his position in the community. The possession of valor, property, wealth, wisdom, or high position is an indication of a man's honor. However, those who build up honor for themselves are denounced by the prophets. Honor is closely associated with justice, righteousness, and peace.

However, should a man be required to suffer dishonor, it does not necessarily indicate either his faithlessness to his calling as a man or his infidelity to God. It could indicate his discipleship. In II Corinthians is the story. Paul said, *"We then, as workers together with him, beseech you also that ye receive not the grace of God in vain...But in all things approving ourselves as the ministers of God, in much patience, in afflictions, in necessities,*

in distresses, In stripes, in imprisonments, in tumults, in labours, in watchings, in fastings...By honour and dishonour, by evil report and good report: as deceivers, and yet true." (II Cor. 1,4,5,8).

Do we remember the Mely village massacre during the Vietnam war? If we will remember, a Lt. Kelly literally executed a number of Vietnamese civilians in the village because they were Viet Cong members. The killings included women and children. It was Lt. Kelly who was the fall guy. He took the heat. The country was divided on this issue but only because they didn't understand the "Duty" and "Honor" concept of the military.

COUNTRY. When the saying, "Duty, Honor and Country" was originated, the word country was synonymous with the word nation. It meant a people of the same ethnic background and with the same mores, morals and customs. It has been said many times that the United States could never endure unless its leaders were righteous and moral.

Were the soldiers of the First Mechanized Division the culprits in burying alive the Iraqi soldiers? No, it wasn't they. It was the same type of leaders who ordered the return of millions of East Europeans and Russians to their death in "Operation Keelhaul," the bombing of Dresden, allowing the attack on Pearl Harbor, the denial of responsibility for the diseases caused by agent orange exposure of our troops, the flagrant and lavish throwing of money at Israel while there is so much need here at home. They are the culprits. These are but a few examples of a government gone mad.

Richard Hoskins in his excellent newsletter [Hoskins Report](#) for October 1, 1991 (P.O. Box 997, Lynchburg, VA 24505) gives another example of just how evil we have become. Under the heading Animal Protection: "Live aborted babies are now being used to develop serum for immunization purposes, according to a story reported recently in the *Cleveland Plain Dealer*, Cleveland Ohio."

"A doctor in Michigan says the aborted fetuses are injected with virus and kept alive for several hours until its body is filled with disease. The fetus is then killed and the blood used for vaccine. Doctors say the process `is an alternative to...senseless slaying of animals from which vaccines were previously made.' (copied from the *S. African Observer*.)"

Who is to blame for this? Certainly the Supreme Court can be blamed. The Congress is at fault. Yes, so is the President to be condemned. There is no question but what the Judeo-Christian Churches are to be criticized heavily for not teaching the church-goers to do whatever, yes whatever, is necessary to remove this evil from the high places. But *"if the blind lead the blind, both shall fall into the ditch."* ([Mat. 15:14](#))

Where is our self-esteem? Where is our pride? What are our goals? Where is the wisdom, the valor? What about the "Duty, Honor, Country" for all of us? Where are our stones? *"My people hath been lost sheep: their shepherds have caused them to go astray, they have turned them away on the mountains: they have gone from mountain to hill, they have forgotten their resting place."*

"All that found them have devoured them: and their adversaries said, We offend not, because they have sinned against the Lord, the habitation of justice, even the Lord, the hope of their fathers." ([Jer. 50:6-7](#))

Yes, our government doesn't feel that they have offended us because they know we have sinned against the Lord. Why do they know that? Because they know that the nation no longer considers the principles of the Bible to be the most important thing in their lives. Because our men have forsaken their responsibilities to themselves, their family, their

community, their nation of people, their God. Our men have become wimps, couch-potatoes, fat and soft, and feminized.

Our men are extraordinarily versed in the statistics of all their "gods" in the football, basketball and baseball arenas. And these seven foot, 250 pound "gods" are identical to those found in [Genesis 6:4](#), *"There were giants in the earth in those days; and also after that, when the sons of God came in unto the daughters of men, and they bare children to them, the same became mighty men which were of old, men of renown."*

Our men have been taught that they, and their ancestors, have exploited the world and the other races. They are continually taught that they are lesser men, physically. It is so bad in large sections of the country that our boys cannot find a spot on the Little League and Pony League teams.

In so many sections of the country our children must go straight home, lock the doors and watch TV until the mother and father come home because it is so dangerous outside that they can't play sand-lot baseball, football or basketball.

It is telling on our boys and young men. It is said that the greatest cause of death now among young white males between 18 and 30 is suicide.

No, our government doesn't feel that they have offended us because they know that most of our men haven't the slightest idea what Moses was talking about in the books of Numbers and Deuteronomy when he described God's rules for organizing and fighting evil. They have been told in their Judeo-Christian churches that all of these rules have been done away with. And who told them this? That great lie started in the Judaized Anabaptist movement. The Christian movement of the time didn't consider the Anabaptists heretics because of their view on baptism. They were condemned because they believed the Laws, Statutes and Judgments of God were "nailed to the cross." Only the ordinances were completed at the cross.

The entire system that has nearly destroyed the Christian movement from within knows that its days are numbered. The same people who modified the system of Hegelian Dialectics and called it Dialectical Materialism created the Soviet Union. This Dialectical Materialism means using dialectics to get the synthesis or result you want. It was a masterful conspiracy to form a world-wide totalitarian government under their direct control. But now they are seeing their dreams of nearly two millenniums in serious trouble.

The time is short. There are great battles ahead and they will continue to be right here on earth. There will be many Christian soldiers destroyed in those battles but does it make any difference? If you haven't already done so, it is time to look in the mirror and make the decision.
