 - B. Addition of Kitchen \$ 75.00
 - C. Each additional hour (with or without kitchen) \$ 50.00

MEMBERS*:

2. One Pavilion (includes Picnic area, trails, and playground) \$ 50.00
(A single pavilion is good for up to 50 guests; if your party is over 50 guests you must rent two pavilions. The maximum number of people is 100.)

3. Use of building:
(Maximum number of guests in clubhouse – 175)
 - A. Ground Floor of Club House / 5 Hours (No Kitchen Use) \$ 100.00
 - B. Addition of Kitchen \$ 50.00
 - C. Each additional hour (with or without kitchen) \$ 35.00

NOTE: If the clubhouse and/or pavilion is not restored to original condition to the satisfaction of the caretaker, you will be billed the reasonable cost of clean-up / restoration.

CAMPING:

1. Camping (for members only) \$ 10.00 per night
 2. Weekend electrical hook-up \$ 25.00

RULES AND REGULATIONS

Do not use water craft of any kind on the lake.

The use and/or sale of beer and alcoholic beverages if positively prohibited.

Children under 18 must be accompanied and supervised by an adult at all times.

Drive on roads only.

Ten (10) miles per hour speed limit on roads.

Trails are for foot traffic only.

Do not pick wild flowers, desecrate trees, shrubs and other flora.

Do not throw trash, table wastes, or wash water into the stream.

Don't be a litterbug. Place all debris in proper receptacle.

Do be careful with fire! No open fires except in designated areas.

No parking in playground area.

Turn off all shelter lights when leaving.

Swim at your own risk. Swimming in stream only.

No fishing in lake. Lake fishing is for members and their families only.

The use of picnic grounds is confined to that area and not the clubhouse or kitchen.

Ranges are closed to all guests who are not accompanied by a member.

No throwing rocks from bank of stream. They are placed there for a purpose.

REMBER: Use the grounds; please do not abuse them.
