DESCRIPTION OF WORK:	The project shall consist of providing all materials, equipment and labor necessary to install the work, appurtenances and associated incidental work as defined as follows: The scope of the project is to rehabilitate the existing street system via a variety techniques including pavement crack and joint cleaning and sealing, and full depth replacement. Work will also include subdrain installation and sidewalk replacement. All work and equipment is to be in accordance with the plans, specifications and contract documents on file with the City Clerk of the City of Oxford, Iowa , which are by this reference made a part of this notice as though fully set out and incorporated herein.
ESTIMATED CONSTRUCTION COST	Estimated Construction Cost \$65,000.
SALES TAX EXEMPTION	The Bidder is eligible to receive an exemption from the State of Iowa Sales Tax. The City expects the Contractor to obtain the Sales Tax Exemption from the City. State of Iowa Sales Tax shall <u>NOT</u> be included in the bid.
BID GUARANTY:	Bid Bond, Cashiers or Certified Check or Credit Union Certified Share Draft, in the amount of 10% of the bid.
COMPLETION DATE:	Work shall commence within ten (10) calendar days after receipt of the written "Notice to Proceed". All work shall have a final completion date of November 15, 2015 , which is subject to any time extension that may be granted by the Council.
PERFORMANCE/PAYMENT /MAINTENANCE BOND:	One hundred percent (100%) of the bid, with a maintenance period of two (2) years from the time of final project acceptance by the Owner.
PAYMENTS:	Monthly estimates equivalent to ninety-five percent (95%) of the Contract value of the work completed during the preceding calendar month with 5% retainage. Remaining retainage, if any, will be paid within 30 days after final acceptance by the City.
