

## **Mava-chapter4.com Privacy Policy**

**Effective: August, 2010.**

### **Information Gathered by the tylerledezmemorial.com**

This is the **Mava-chapter4.com** 's online privacy policy. This policy applies only to activities **Mava-chapter4.com** engages in on its website and does not apply to **Mava-chapter4.com** activities that are "offline" or unrelated to the website. **Mava-chapter4.com** collects certain anonymous data regarding the usage of the website. This information does not personally identify users, by itself or in combination with other information, and is gathered to improve the performance of the website. The anonymous data collected by the **Mava-chapter4.com** website can include information such as the type of browser you are using, your IP address and the length of the visit to the website.

### **USE AND DISCLOSURE OF INFORMATION.**
