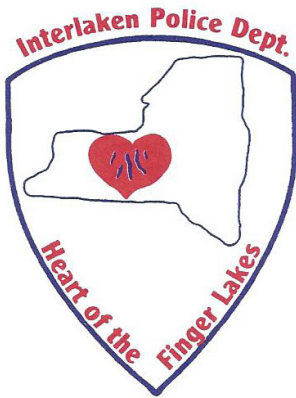

### **Grants**

- I applied for an aggressive driving grant with selective traffic enforcement for \$5,400. This is our first time applying for this type of grant in many years.
- We have started to use the Stop DWI grant money. I will be sending in vouchers on a Monthly basis. We will receive reimbursement from the Stop DWI program through out the year as apposed to the end of the year reimbursement as we have in the past.
- I am working with Diane and Chris Nelson on a Grant for AED's through the Federal government. We will be meeting this Friday to go over details of the grant.
- I will be putting in a request for an increase in funding for the 2014 budget year during the July 2013's Stop DWI Committee budget meeting. I will also be requesting equipment for the patrol car, I will have more details about this at the July Board meeting.

### **Volunteers**

- Alexa Anderson and Christie Shaffer will be volunteering this summer to help input older cases into SJS. I will be having both sign a waiver for liability and confidentiality forms before they start.
- I am also doing a back ground investigation on a resident at Conifer Village to do volunteer crossing guard details next school year.
- I will also be soliciting TC3 for an intern for the fall of 2013 semester.

### **Olde Home Days**

- We were approved for our permit from NYS DOT. We have a safety plan and mapped detour route on file with NYS. Next year will be easier as we will only have to update the permit, safety plan and detour route every year.
