

MODIFIED PROPOSAL

Years 1-3 Flat Rate, Years 4&5 3% Increase

**TO: BOARD OF HARRISON TOWNSHIP TRUSTEES
LICKING COUNTY, OHIO**

The undersigned hereby proposes and agrees, if this proposal is accepted, to enter into a Contract to furnish all labor, materials and equipment for the collection, transportation and disposal of all garbage, trash, refuse, yard waste and recyclable materials from residential premises within the unincorporated area of Harrison Township in accordance with the Advertisement (Notice to Bidders), Information for Bidders, Contract and Specifications therefore (the "Contract Documents") and to furnish a bond or bank cashier's check satisfactory to the Board of Harrison Township Trustees in the amount of one hundred thousand dollars (\$100,000), as a guaranty for the faithful performance and adherence to the Contract and Specifications; for the following rate:

Measure of fuel price increases shall be tied to weekly US Mid West On-Highway Diesel Fuel Prices for the as defined by the US Department of Energy's US Energy Information Administration. A fuel adjustment will reflect a set and equal incremental increase over the established base price during the term of this contract. The established base price of diesel fuel is \$3.00 per gallon. The increase will be applied as fuel costs per gallon increase in four cent increments according to the chart below and beyond.

The fee would be implemented for only the customers with recycling services. The fee increase equates to .07 cents per month for every \$5.00 incremental increase in additional cost above \$25.00 per ton
