

I, Given name _____ the herein named living man/woman, being of lawful age and of sound mind hereby with this instrument expatriate myself from section one of the Fourteenth Amendment, from being primarily a federal Citizen and am now primarily a non-corporate, non-citizen, non-national and am here forth of the bloodline of these united states of the union/United States of America (by Supreme Court Case 1881) pursuant to 15 Statutes at large 249-250 and am exempt from corporate UNITED STATES, STATES and their political subdivision jurisdictions. “Whereas the right of expatriation is a natural and inherent right of all the lawful bloodline American people, indispensable to the enjoyment of the rights from the creator of life, liberty, and the pursuit of happiness; and whereas in the recognition of this principle this government of we the people have freely received emigrants from all nations, and invested them with the rights of citizenship; and whereas it is claimed that such American citizens, with their descendants, are subjects of foreign states, owing allegiance to the governments thereof; and whereas it is necessary to the maintenance of public peace that this claim of foreign allegiance should be promptly and finally disavowed: Therefore, 'Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That any declaration, instruction, opinion, order, or decision of any officers of this government which denies, restricts, impairs, or questions the right of expatriation, is hereby declared inconsistent with the fundamental principles of this government.' 15 Stat. 223—224, R.S. § 1999, 8 U.S.C. 800, 8 U.S.C.A. § 800.
