The City Council of the City of New Munich met in regular session at 6:30 p.m., in the City Hall. Shawn Duevel, Elmer Boecker, Sandy Zierden, Kurt Thelen and Ron Doll were present.

On a motion by Elmer Boecker, seconded by Kurt Thelen and carried the minutes from March 7, 2022 were approved.

Fire Chief, Al Fiedler was present. 4 Medical calls. February, First Responders Refresher was completed. Hennepin County has radio's to give away. Bills-Med Compass for exams and fit test

Waste/Water Operator, Tom Valerius was present. Water-1 resident has some dirty water again. 681 main street was coming up empty pipe. Maybe tampered with. Tom checked it out and looked fine. Still had dust on it so wouldn't have been tampered with. Just need to watch the water bill when it come out. Waste Water-Sample done at New Munich Meats. Rodents making holes at the ponds. There is a broken fence post by pond. Been shoveling and watching the lift stations.

New Munich Jaycees—Still looking at adding onto the bathrooms for a warming house for skating rink.

Building Permits—Kelly Thielen for a 10x50 piece of cement, Paige Linn for a temp dog fence. Motion made by Kurt Thelen to approve the 2 permits, 2nd by Elmer Boecker. Motion carried. Jesse LeClaire 20x22x8 add onto the garage. Plus a 10x12 movable storage shed. The existing garage sits on the property line. Contact Susan the attorney. He and neighbor need to have legal maintenance easement. Motion made by Sandy contingent on the paperwork for the maintenance easement, 2nd by Kurt Thelen. Motion carried.

Denise Klaphake is possibly interested in Lot 10 in Munich Acres. Could home face east instead of North? Council discussed having all the houses face the same direction and come to an agreement that the houses in Munich Acres will all need to face north even lot 10.

Was asked about covenants for Munich Acres. Will reach out to Attorney Susan to get a copy of them.

Steve Worms was present to talk about the addition onto the church, moving the driveway, and redoing the old water line. Water line is currently 4 inch pipe and the water get stale. Build on the font of the church enter on the North and South sides. Is it zoned commercial or residential? Sandy will find information and get it to Steve.

Steve Worms talked about the Veterans Memorial by the Swings or the Volleyball Courts? Steve would like to see a 20x30 Maybe attach right to the sidewalk. Council discussed and came to a decision to place the possible future veterans memorial in front of the volleyball courts. Motion by Ron Doll, 2nd by Sandy Zierden. Motion carried.

Dave Blommel with SEH—Has done a lot of researching. Does not think our sewer needs any work. Forced main, does it get done when we have the contractor in town? Water system is older. Storage tanks seems to be in good condition. Main street, western, and liberty probably should get done and replaced. Main street will be in 2023. Encourages us to do it all in 1 shot. USDA-try to get funding for this. Has an agreement of 40,000, will ask USDA Rural Development for more that we need. Will do application to PFA as well. Sandy Zierden makes motion to approve agreement for professional services pending attorney approval 2nd by Ron Doll, Motion passed.

On a motion by Kurt Thelen, seconded by Elmer Boecker and carried the annual renewal of tobacco license for Hot Shots Bar and Grill and New Munich Gas and Grocery were approved.

On a motion by Sandy Zierden, seconded by Kurt Thelen and carried the annual renewal of liquor license (On Sale, Off Sale, Sunday) for Hot Shots Bar and Grill were approved.

On a motion by Ron Doll, seconded by Elmer Boecker and carried the 2am Liquor License was approved for Hot Shots Bar and Grill.

Leaf Pickup could be May 2nd or 3rd. Need to hear from West Central yet.

Garbage contact has been signed. Commercial can go with who they would like.

250 Liberty street needs to be cleaned out yet. Ann has a contact and will reach out to him.

Have a couple of really high outstanding utility bills. Susan our attorney gave a couple of options as to what we could do about them.

Audit will be coming up in May.
